Eligibility Criteria

- 1. Minimum qualification is Class **VIII** passed but those who have passed **HSSLC** (10+2) or above shall be ineligible to apply for the posts.
- 2. The candidate must not be less than **18 years** and not more than **43 years** of age as on date of the Advertisement.

REQUIRED DOCUMENTS ALONG WITH THE APPLICATION:

- A. Self-attested copies of the educational / other qualification certificates.
- B. The candidate should paste their recent passport sized coloured photograph in the given space of the application form and sign across it and additional 02 (two) copies of photograph should be stapled on the top right corner of the application form.
- C. Self-attested copy of Caste certificate.

1. The candidate must submit duly filled up application in prescribed form along with self-attested copies of testimonials as mentioned above. - 2. Candidates who are already in Govt. Services must apply through proper channel.
- 3. Date of Interview / Test will be notified later on.
- 4. A provisional **Select List** of candidates eligible for appearing in the Test / Interview along with **Reject List** will be uploaded in the official website of the District Judiciary **www.kokrajharjudiciary.gov.in.** in due course of time.
- 5. If any candidate is found to have suppressed his educational qualification or give any wrong information at the time of applying for the post, his candidature shall be liable to be rejected

or terminated at any point of time.

- 6. Incomplete applications, applications without proper supporting documents or without applicant's signature etc will be summarily rejected.
- 7. Applications submitted in any other mode, except as indicated will be summarily rejected without any communication. Applications received after due date will be rejected. No application will be entertained after the aforesaid time schedule including the application submitted through post.
- 8. Candidates who are already in Govt. service will have to submit "No Objection Certificate" from the present authority at the time of Viva-Voce/ interview, if shortlisted.
- 9. If, information submitted by an applicant in his/her application found suppression of material facts including educational qualification, after selection, the same will be forfeited and criminal proceedings will be initiated for playing fraud and suppression of material facts and in such cases, candidate have no right to claim for selection and same will be filled up as per decision of the Selection Board and Board decision will be the final.
- 10. Candidate will be responsible for any mistake made by him/her in the application form.
- 11. Canvassing directly or indirectly will lead to immediate disqualification of the candidature.
