Applications are invited in Standard form as published in Assam Gazette in Part IX from the eligible candidates who are citizens of India as defined in the Constitution of India for engagement of **01 (one) Driver (Contractual)** in the office of the District Legal Services Authority, Kokrajhar at a monthly remuneration of Rs. 15,000/ (Rupees Fifteen Thousand) only. **The engagement shall be purely Contractual and it may be terminated at anytime without assigning any reason.** The Contract period shall initially be for a period of 1 (one) year which may be extended depending upon requirement and performance which shall be subject to the approval of the Assam State Legal Services Authority, Guwahati. The terms and conditions for the above engagement, minimum requisite qualifications, honorarium etc. is as follows:

How to apply: Candidates are required to submit their applications directly to the Office of the District Legal Services Authority, Kokrajhar.

Other Terms and Conditions:-

1. Candidates must submit self-attested copies of relevant testimonials/certificate regarding identity, educational qualification, age, caste, employment exchange registration card, experience certificate, valid professional driving license and two recent passport size photographs along with the application. **Candidates must also submit self-attested copy of certificate showing minimum three years experience in professional driving.**
2. Candidates are required to provide their phone number (preferably WhatsApp No.) and E-mail ID in the application form without fail.
3. Candidate must be an Indian Citizen as defined in Constitution of India.
4. Candidate must not be less than 18 years and not more than 40 years of age as on the date of publication of this advertisement. In appropriate cases, relaxation of age will be admissible as per the existing rules of Government of Assam.
5. Eligible Candidates for skill test (i.e. driving test) and interview have to produce Original testimonials regarding identity, educational qualifications, date of birth, caste, employment exchange registration card, valid professional driving license, work experience in professional driving at the time of skill test and Interview for the purpose of verification and scrutinization.
6. The application should be addressed to **the Chairman, District Legal Services Authority, Kokrajhar.**
7. The last date fixed for receipt of applications is **8th June, 2026** (till 5:00 PM). Candidates are required to submit their applications in the Drop Box set up for the purpose in the office of District Legal Services Authority, Kokrajhar. Applications may also be sent by post. This Authority will not be responsible for any postal delay. No application shall be received after 8th June, 2026 (in any mode).
8. Incomplete and unsigned applications will be summarily rejected without assigning any reason thereof.
9. No TA/DA shall be admissible to the candidates for appearing in the skill test and interview.
10. Candidates who are already in Government Service (Central/State or PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer at the time of document verification and they will have to submit release order at the time of joining.

11. Candidates must mention prominently the name of post applied for on the right-hand corner of the envelope containing the application.
12. Canvassing directly or indirectly shall be liable for disqualification of the candidate.
13. The decision of the Selection Committee shall be final in respect of any dispute; if arises out of the recruitment process.
14. The selection shall be made on the basis of marks obtained in skill test (i.e. driving test) followed by interview. **Only those candidates who secure minimum 60% (Sixty percent) marks in the skill test shall be called for the interview.** The total marks for the skill test shall be 60 (Sixty) and that for the interview shall be 40 (Forty). Final selection shall be made on the basis of aggregate marks obtained in skill test and interview.
15. List of eligible candidates and other information relating to the recruitment process will be uploaded in the official website of the Kokrajhar District Judiciary from time to time. No individual call letters will be issued for skill test or interview. Candidates are advised to regularly check the official website of Kokrajhar District Judiciary.
16. Information submitted by an applicant in his/her application will bind the candidate and if found to be false, his/her candidature will be cancelled forthwith and he/she shall be liable for criminal prosecution.
17. The admission of candidates at all stages of selection process will be purely provisional and subject to satisfying the prescribed eligibility conditions. The application will be subject to scrutiny at every stage and shall be rejected if any defect is detected.
