Applications are invited in **STANDARD FORM** from the eligible candidates for engagement of **15 (fifteen) nos. of Para Legal Volunteers (PLVs)** under this authority. The application must be accompanied with two recent passport size photographs and self attested copies of all testimonials/documents in respect of age, residence, educational qualification, caste, past work experience (if any) etc. The applicants should have the following qualifications to apply for engagement as PLVs-

1. The applicant must be a citizen of India and a local resident of Kokrajhar District.
2. He/she must have attained the age of majority.
3. The applicant should have passed at least matriculation.

As per the Scheme for Para Legal Volunteers as framed by National Legal Services Authority (NALSA), PLVs can be selected from below mentioned groups:-

- a. Teachers (including retired teachers).
 - b. Retired Government servants and senior citizens.
 - c. M.S.W students and teachers.
 - d. Anganwadi Workers.
 - e. Doctors/Physicians.
 - f. Students and Law Students (**till they enrol as lawyers**).
 - g. Members of non-political, service-oriented NGOs and Clubs.
 - h. Members of Women Neighbourhood Groups, Maithri Sanghams other and Self-Help Groups including of marginalized/vulnerable groups.
 - i. Educated Prisoners with good behaviour serving long-term sentences in Prison.
 - j. Any other person whom the District Legal Services Authority deems fit to be identified as PLV.
4. **The work of PLV does not carry any salary, remuneration or wages except honorarium fixed by the National Legal Services Authority/Assam State Legal Services authority from time to time, as per rules.**
 5. The engagement of the Para Legal Volunteer may be terminated at any time without assigning any reason if he/she is not found suitable to continue as a PLV.
 6. Duties of a Para Legal Volunteer include educating people about their Constitutional and Legal Rights, making people aware of the nature of their disputes/issues/problems, visiting Police Station and ensuring that the arrested person gets legal assistance, if necessary, assisting victims of crime in getting proper compensation, visiting Children's Home/Observation Homes and providing legal services to the inmates, generating awareness amongst people about benefits of settlement of disputes through Lok Adalats, Conciliation, Mediation and Arbitration etc.

7. The filled up application should be submitted to the office of the District Legal Services Authority, Kokrajhar on or before **15.10.2026** (till 5 P.M.). The applicants must furnish their mobile number in their application for further communication. Applications may also be submitted through post/courier but this authority shall not be responsible for any delay caused by the Postal Department/Courier service.
8. Incomplete applications will be rejected. No applications will be entertained after the last date.
9. The decisions of the Selection Committee in short-listing the number of candidates for interview and selection of PLV shall be final.
10. In case of any objection regarding selection of PLV's the decision of Selection Committee shall be final and binding upon all concerned.
11. List of eligible candidates for interview will be notified in the official website of Kokrajhar District Judiciary in due course. The applicants are advised to regularly visit the official website of this Judiciary as all information pertaining to the engagement of PLVs shall be uploaded only on the official website from time to time. No separate Call Letter shall be issued for the interview. There shall be no other mode of communication with the candidates.
12. Canvassing directly or indirectly will disqualify the candidate.
13. No TA/DA will be provided for appearing in the interview.
14. The Selection Committee reserves the right to alter/modify or change any of the terms or conditions including selection criteria etc. mentioned in the advertisement and in such an eventuality due notice thereof will be published at the discretion of the undersigned only via the official website of Kokrajhar District Judiciary.
15. All other condition(s) which are not specifically provided herein shall be decided by this Authority from time to time.

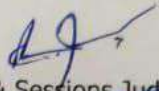
