NOTICE

(Appointment by way of promotion from Group 'C' employees to the Upper Divisional Clerk (Grade-III))

In view of resolution of the Centralized Selection & Appointment Committee dated 20.07.2026, applications through the respective Principal District & Sessions Judge are invited from the eligible Group 'C' employees [Bailiff, Driver, Process Server, Daftdari, Attendant, Attendant (Special), Night Guard] in **prescribed format** for consideration of appointment by way of promotion from Group 'C' employees to the Upper Divisional Clerk (Grade-III) on tentative 876 promotional post of Upper Divisional Clerk (Grade-III) in the different Judgeships of Bihar in the light of Rule 15 of 'The Bihar Civil Court Officers and Staff (Recruitment, Promotion, Transfer and other Service conditions) Rules, 2022'.

- (1) **METHOD OF RECRUITMENT** - Group 'C' employees holding requisite qualification in 1:2 ratio i.e. for three vacancies in appointment on limited examination & Interview, one shall be filled up by Process Server, Daftari and Driver and two shall be filled up from Attendant, Attendant (Special) and Night guard posts having with experience as per Kalawadhi of 'five and a half years'.
- (2) **CUT-OFF DATE** – The cut-off date for calculation of Kalawadhi and requisite qualification will be from the date of publication of this notice on the website of Civil Courts, Patna.
- (3) **Qualification** - 'Bachelor's degree in any discipline from a recognized University and Knowledge of Computer is essential.'
- (4) **Mode of recruitment** - 'Through Limited Examination & interview'.
- (5) **How to apply:** -
 - i. The eligible Group 'C' employees i.e. Bailiff, Driver, Process Server, Daftdari, Attendant, Attendant (Special), Night Guard can **apply in the prescribed format of Application Form** enclosed with this notice.
 - ii. **Enclose** self-attested copies of the documents/certificates of requisite qualification with the duly filled *Application Form*.
 - iii. **The duly filled Application Form with enclosures has to be submitted** in the office of the **respective Principal District & Sessions Judge within 30 days of publication of this notice** on the website of Civil Courts, Patna.

- iv. The office of the Principal District & Sessions Judges shall scrutinize the Application Forms received within due date in such a way that the entries made by the employees regarding his **personal and educational qualification details are as per the Service Record of the concerned employee.**
- v. The *Application Form* shall be countersigned by the competent authority / any other officer authorized by the learned Principal District & Sessions Judge of the respective Judgeships by way of signing the column of *Certificate* provided in the last position of application form to the effect that *the above mentioned personal and educational qualification details of the employee have been verified and are as per the Service Record of the employee concerned.*
- vi. The respective Principal District & Sessions Judge will transmit the Application Forms along-with enclosures of such employees in the **prescribed format**, to the Convenor, Centralized Selection & Appointment Committee.
- vii. The Committee reserves the right to scrutinize applications of the employees on the basis of educational qualifications or other criterions.
- viii. The Candidates are required to produce the original document(s)/certificate(s) in support of all essential qualification certificates required for the post, Certificate of computer proficiency, or any other document as mentioned in his / her application form as & when required by the Centralized Committee.

(6) Mode of Examination: -

- i. Written test will be of **90 Marks**.
- ii. **Interview of 10 marks will be held** of the qualified employees in the Written Test.
- iii. **The minimum qualifying in the written test and Computer operating test will be 40%.**

(7) Syllabus of Written Test: - The written test shall consist of the following subjects: -

- i. **English Language and Grammar (20 Marks):** - Letter Writing, Essay, Precis, Comprehension and Vocabulary.
- ii. **Hindi Language and Grammar (20 Marks):** - Consisting of Letter Writing, Essay, Precis-Writing, Comprehension and Vocabulary.
- iii. **General Knowledge and Current Affairs (15 Marks):** - In this section questions will be based on History, Civics, Geography, Everyday Science, Constitution of India, Legal Terminology.

- iv. **Mathematics of matriculation standard (15 Marks):** - The test shall comprise questions on topics viz. BODMAS, Simple Calculations, Problem based on Time and Distance, Time and Work, Calculation of Simple / Compound Interest, Ration and Proportion.
- v. **Test of Reasoning (Verbal and Analytical type) (10 Marks):** - Problems based on English alphabets, Sitting Arrangement, Circular Sitting arrangement, Blood relation, Analogy Test, Ranking Test, Syllogism, Problems based on Venn-diagram.
- vi. **Basic Computer Knowledge (10 Marks):** - History of Computers, Fundamentals of Computer and terminologies, Computer abbreviations, Basis of Hardware and Software, Keyboard shortcuts, Operating system basics, Basic Functionalities of MS-Office (Word, Excel and Power-Point), Internet terms and services, Networking and communication, Security Tools and Viruses.
