

## ROLL OF ADVOCATES FOR DISTRICT COURT RAE BARELI.

### NOTICE

As per the directions passed by the Hon'ble Court in Writ PIL No. 2436 of 2019 communicated vide Hon'ble Court's letter No. 534/Admin. G-I/Allahabad, dated 09.01.2020, the Roll of Advocates was prepared in Rae Bareli Judgeship, in compliance of directions issued in the aforesaid letters. Some advocates have submitted applications to include their names in the Roll of Advocates for District Court, Rae Bareli. In compliance of order dated 01.01.2025 of respected District Judge Sir, applications, in prescribed proforma, from the Advocates, whose names do not find place in the Roll of Advocates of this Judgeship, are invited by 15.01.2025. The prescribed proforma may be downloaded from the official website of the District Court, Rae Bareli as well as from the Central/District Bar Associations of Rae Bareli Judgeship. The Advocates who are already enrolled in the Roll of Advocates need not to apply.

All the forms duly filled (neatly typed by computer) to be submitted to the Administrative Officer, Office of District Judge, Rae Bareli positively by 15.01.2025 alongwith following documents:-

- (a) Two passport size coloured photographs with band (one self attested photograph be affixed on the application).
- (b) Self attested copy of the registration certificate issued by the Bar Council of Uttar Pradesh.
- (c) Self attested copy of LL.B. Final Year Result/Degree.
- (d) Self attested copy of proof of applicant's residence and office address (i.e. Ration Card/Telephone Bill/Driving License/Voter ID Card/Aadhar Card/Passport/Electricity Bill/Bank Pass-book).
- (e) Self attested copy of proof of practice at Bar Associations of Rae Bareli Judgeship
- (f) Self attested copy of proof of Date of Birth (Certificate of High School).

In case the applicant is not a member of the Bar Associations of this Judgeship, an affidavit to be submitted before the Chairman. The Roll of Advocates, Rae Bareli, to the effect that the applicant is ordinarily practicing in this Judgeship, be attached with the application form for which applicant has to submit an affidavit on the prescribed proforma (Annexure-B).

It is clarified that Advocates who have passed their qualifying examination (LL.B.) in the year 2009-10 and thereafter, will be provisionally enrolled unless they pass All India Bar Exam (AIBE) within 2 years from the date of enrollment in the Bar Council of U.P. and submit the Certificate of Practice, issued by Bar Council of India and in default of submitting the same, their names will be automatically struck off from the Roll of Advocates.

It is further clarified that Advocates who had graduated in the academic year 2009-10 and onwards, having completed two years of enrollment with Bar Council of U.P. will be rolled on Roll of Advocates only after they furnish the Certificate of Practice, issued by Bar Council of India.

After receipt of the form, a list of defective forms will be pasted on Notice Board of District Court, Rae Bareli as well as Bar Associations of this Judgeship and also a copy be published on official website of District Court, Rae Bareli. It is duty of applicant to verify whether his/her name present in defective list or not. Such applicants whose name mentioned in the list will be required to remove the defects within three days of the publication of list. Thereafter, final list of Roll of Advocates will be published on the official website of District Court, Rae Bareli.

In case the applicant is not a member of this associations, an affidavit to be submitted before the Chairman, Roll of Advocates, Raebareli, to the effect that the applicant is ordinarily practicing at District Court Raebareli, be attached with the application form for which applicant has to submit an affidavit on the prescribed proforma (Annexure B).
2. Please also attach your two recent passport size coloured photos with band. One self- attested photo be pasted on the application itself while the second photo be unattested.
3. The Advocates who had passed their qualifying (LL.B.) Examination in the year 2009-10 and thereafter, will be provisionally enrolled unless they pass All India Bar Exam (AIBE) within 2 years from the date of enrollment in the Bar Council of U.P. and submit the **Certificate of Practice (COP)**, issued by Bar Council of India and in default of submitting the same, their names will be automatically struck off from the Roll of Advocates. **(As per clarification issued by Bar Council of India, New Delhi, the advocates whose LL.B. results have been declared on or after 01.07.2010, are mandatorily required to pass All India Bar Examination.)**

The Advocates who had graduated in the academic year 2009-10 (LL.B. results declared on or after 01.07.2010) and onwards, having completed two years of enrollment with Bar Council of U.P. will be enrolled on Roll of Advocates only after they furnish the **Certificate of Practice (COP)**, issued by Bar Council of India.
