Applications are invited from the citizens of India as defined under article 5 and 6 of the Constitution of India in the Standard Form as published in part IX of the Assam Gazette for filling up the following post purely on contractual basis under the establishment of the District Legal Services Authority, Dima Hasao at a fixed pay of Rs. 15,000/- per month.

**1. ELIGIBILITY CRITERIA:**

- i. Minimum educational qualification for the post is VIII (eight) Passed.
- ii. The candidate must possess a valid driving license (LMV).
- iii. The candidate must possess Employment Exchange Registration number for the state of Assam.

**2. AGE LIMIT:**

The candidate should not be less than 18 years and not more than 40 years of age as on 01.01.2026. age relaxation shall be as per Govt. norms for reserved categories.

**3. SELECTION PROCESS:**

Stage	Description
Stage 1	Driving test of 50 (Fifty) Marks.
Stage 2	Interview/viva-voce of 50 (Fifty) Marks.

**4. HOW TO APPLY:**

- i. The candidate shall have to submit self-attested documents (photocopy) of all educational qualification, age proof, valid driving license, employment exchange registration certificate and other necessary testimonials along with 3 copies of recent passport size photographs along with the applications form.
- ii. The candidate must indicate prominently the name of the post applied for on the right-hand corner of the envelope containing the application.
- iii. The candidate must provide their contact (Mobile) no. in the application form.
- iv. Candidates serving in Govt. department must apply through proper channel.
- v. Completed applications along with all testimonials as mentioned above should be addressed to **"The Chairman, District Legal Services Authority, Jatinga Court Complex, Jatinga, Haflong, PO- Haflong, PS- Haflong, Dima Hasao, Pin- 788819"**.

- vi. Applications sent through post super scribed as "**Application for the post of Driver (Contractual)**" should reach the office of the undersigned within 15 days of publication of the advertisement.
- vii. Candidates may also drop their applications in the "**Drop Box for the Post of Driver (Contractual)**" to be kept at the premise of Office of the District Legal Services Authority, Dima Hasao, Jatinga Court Complex, Haflong within 15 days of publication of the advertisement.

#### **5. TERMS AND CONDITIONS:**

- i. The admission of candidates at all stages of the selection process will be purely provisional at any time before or after the selection process. If, it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature shall stand cancelled without any prior notice.
- ii. The Selection Committee shall not be responsible for any postal delay in delivering the applications and those applications will be summarily rejected without any notice.
- iii. Calling of candidate to participate in the selection process or issuance of admit card/call letter etc. does not necessarily mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and the selection /appointing authority reserves the right to reject the candidature of any candidate at any time.
- iv. The list of the eligible candidates and list of the rejected candidates will be uploaded in the official website of Dima Hasao District Judiciary (**dimahasao.dcourts.gov.in**).
- v. The date, time and venue of driving test/interview/viva-voce for the eligible candidates will be published in the official website of Dima Hasao District Judiciary (**dimahasao.dcourts.gov.in**). No individual call letter will be issued to eligible candidates.
- vi. Valid employment exchange registration number is mandatory for those who are not in service. The candidates shall have to mention the Employment Exchange Registration number and date in the application form.
- vii. False information in the application form shall render the candidate liable for prosecution under relevant laws.
- viii. The appointment and conditions of service of the selected candidates shall be governed by the relevant Service Rules.
- ix. Canvassing by any means will immediately lead to rejection of candidature.
- x. No TA/DA shall be paid to the candidates.
- xi. All other matters which are not specifically mentioned in this advertisement shall be as decided by the selecting/appointing authority.
