Applications are invited from the local residents in the prescribed Standard Form of Application as published in the Assam Gazette Part-IX for selection to **the post of 20 (Twenty) Nos. of Para Legal Volunteers (PLVs)** under District Legal Services Authority, Dima Hasao.

Terms and Conditions:-

1. He/she must be a citizen of India and should be from any one of the following groups :
 - (i) Teachers (including retired teachers)
 - (ii) Retired Govt. Servants and Senior Citizens.
 - (iii) Students and Teachers of Master of Social Work.
 - (iv) Anganwadi workers.
 - (v) Doctors/Physicians.
 - (vi) Students & Law Students (till they enroll as lawyers).
 - (vii) Members of Non-political, service oriented NGOs and Clubs.
 - (viii) Members of Women Neighborhood Groups, Maithri Sangrams and other Self-help Groups including marginalized /vulnerable Groups.
 - (ix) Any Social Worker.
 - (x) Persons from Defense Background (Ex-servicemen).
2. The applicants should have a minimum educational qualification of HSLC
3. The applicants should have a capacity for overall comprehension and should have the mind-set to assist the needy in society coupled with the compassion, empathy and concern for the betterment of marginalized and weaker sections of the society.
4. The minimum age for the selection of Para Legal Volunteers should not be less than 18 years as on the date of publication of this advertisement.

5. Preference will be given to the candidates who possesses basic computer skills, driving skills and any other relevant skills.
6. The work of PLVs does not carry any salary, remuneration or wage. The PLVs will receive an honorarium according to their engagement in different capacities. The honorarium will be of the amount fixed by the State Authority i.e., the Assam State Legal Services Authority (ASLSA) as per the prevailing rules.
7. The Applicants shall furnish their contact numbers in their respective application forms.
8. The applicants must submit their applications along with 2 (Two) Nos. of passport photos, self-attested copies of all relevant documents in a sealed envelope.
9. The envelope containing the application form should be super scribed **"For the post of Para Legal Volunteer"** and should be addressed to **"The District & Sessions Judge-cum-Chairman, District Legal Services Authority, Dima Hasao, P.O & P.S Haflong, Pin 788819"**. The filled up applications should reach the office of the District Legal Services Authority, Dima Hasao, Haflong **on or before 03rd October, 2026 by 05.00 P.M.**
10. The applicants are directed to deposit their applications in the **"DROP BOX FOR THE POST OF PLV"**. The Drop Box will be kept in the ground floor of the District Court Building at Jatinga.
11. Incomplete application will be rejected without assigning any reasons. No application will be entertained after the last date fixed.
12. The list of selected and rejected candidates will be notified in the official website of Dima Hasao District Judiciary i.e., **(<http://dimahasaojudiciary.gov.in>)**.
13. The decisions of the Selection Committee in short listing the number of candidates for Interview and Selection of PLV shall be final. They will be selected as per relevant scheme in this regard.
14. Selected PLVs shall be required to undergo training programme as per decision of the District Legal Services Authority, Dima Hasao.
15. Canvassing directly or indirectly will disqualify the candidate.
