ELIGIBILITY CRITERIA

1. Qualification

For the Post of Orderly/Chowkidar, the candidate must have passed matric (10th) from a recognized Board.

2. Domicile

The Candidates must be permanent resident/domicile of UT of J&K possessing of domicile certificate in terms of Notification issued by the General Administrative Department of UT vide S.O No 166 dated 18.05.2020.

- d) The printout of the Application Form (Annexure A) alongwith the fee payment draft and requisite copies of documents shall be annexed with the application form.
- e) Submission of Application Form (Annexure A) and payment of fee shall not be entertained after the cut-off date fixed for receipt of the same.
