In view of instruction from the Ld. District Judge, Darjeeling, vide Memo No.37/N Dated:14.02.2025, the sealed quotations/tenders are hereby invited from competent persons/firms/company/registered vehicle owners for providing a suitable vehicle for the use of Protocol Duty of Siliguri Sub-Divisional Court, on the monthly hiring basis as per notification number 3564-WT/3M-81/98 dated 24.11.2008 of Transport Department, Government of West Bengal and on the following terms and conditions.

The quotations must be submitted in sealed cover within 29.03.2025 by 04:00 pm positively and such quotations will be opened on 01.04.2025 at 05:00 pm. No quotations/applications shall be entertained after the prescribed date and time. The lowest bidder would be selected for consideration.

TERMS & CONDITIONS

1. The owners of vehicle with valid road permit can apply. They shall produce valid mechanical fitness certificate from the Competent Authority. Self attested photocopies of valid certificate of pollution, Insurance and Road tax are to be attached with the quotations.

2. The vehicle will have to be fitted/provide with clean seat covers, reading lamp/AC and Seat belts(Front Rear).

3. The driver employed by the owner must carry a mobile phone in working condition for which no separate payment shall be made.

4. The vehicle should always be kept in good condition with sufficient fuel in the tank. In case of breakdown during duty, it shall be the responsibility of the contractor/owner to provide a substitute vehicle, which is of similar make as replacement immediately.

5. No payment shall be made in advance. All payments shall be made on monthly basis or availability of the government fund.

6. The undersigned reserves the right of acceptance or rejection of any quotation/tender and to cancel the tender process at any time prior to the award of contract assigning any reason. The acceptance of quotation and award of contract is subject to approval of the Ld. District Judge, Darjeeling


