The Court-Manager, Civil Court, Saran at Chapra is directed to verify all the documents submitted by the candidates at the time of their joining. As per direction of the Convenor, Centralized Selection and Appointment Committee-cum-Principal District & Sessions Judge, Patna , the Court-Manager is also directed to verify the following prior to joining of the aforesaid candidates:-

- (a) The candidate must have to produce the Caste Certificate/N.C.L. (as the case may be) as per their selection category.
- (b) The candidate selected in EWS category must have to produce the Certificate of EWS category, based on income for the financial year 2021-2022 along-with residential Certificate.

As per direction contained in the aforesaid Letter of the Convenor, Centralized Selection and Appointment Committee-cum- Principal District & Sessions Judge, Patna, where the original certificate shall require its verification from the concerned institution/source, joining of such candidate shall be accepted provisionally and shall be subject to the said certificate being found correct, genuine and authentic.
