Office Order No. 196/2023

dated 31.10.2023.

Vide Order No. 194/2023 dated 20.10.2023 of this Office, final result for the appointment of Peon/Orderly of Civil Court, Koderma and Family Court, Koderma and Driver of Family Court, Koderma was published. Accordingly, office was directed to issue appointment letters to the selected candidates. During the course of filling up the address of Shri Deepak Kumar (Roll No. 1511) in his appointment letter pursuant to his selection for the post of Driver, Family Court, Koderma, it was found that Shri Deepak Kumar did not fulfill the minimum essential educational qualification for the post of Driver, Family Court, Koderma as per advertisement No. 01/2023 of Civil Court, Koderma. Before taking a final decision regarding candidature of Shri Deepak Kumar, an opportunity was granted to him by District Court Selection Committee, Civil Court, Koderma to submit his essential certificate of matriculation for re-verification. In response to the notice, Shri Deepak Kumar appeared before the Judge-In-Charge-Cum-Member Secretary, District Court Selection Committee, Civil Court, Koderma. After proper re-verification of essential certificate of matriculation produced by Shri Deepak Kumar before Judge-In-Charge-Cum-Member Secretary, it was found that he does not possess the minimum necessary educational qualification for the post of Driver, Family Court, Koderma as per Advertisement No. 01/2023 of Civil Court, Koderma. In such circumstances, the District Court Selection Committee, Civil Court, Koderma has recommended for cancellation of candidature of Shri Deepak Kumar (Roll No. 1511) and in his place, the name of the candidate mentioned at serial no. 1 of the waiting list i.e Shri Suraj Kumar Rathaur (Roll No. 1633) was recommended for the post of Driver, Family Court, Koderma to the Hon'ble High Court for approval vide Letter No.1283/2023 dated 27.10.2023.

Subsequently, vide its Letter No. 637/Admn. Misc. dated 30.10.2023, the Hon'ble Jharkhand High Court has been pleased to accord approval of the recommendation of District Court Selection Committee, Civil Court, Koderma and pleased to cancel the candidature of Shri Deepak Kumar (Roll No. 1511) for the appointment of Driver, Family Court, Koderma on the ground of not fulfillment of necessary educational qualification for the said post as advertised in Advertisement No. 01/2023 of Civil Court, Koderma. Further, the Hon'ble High Court has also been pleased to approve the name of Shri Suraj Kumar Rathaur (Roll No.1633) from the "waiting list candidates" at serial no. 01 for the appointment to the post of Driver, Family Court, Koderma in place of Shri Deepak Kumar (Roll No. 1511).

In view of this approval by the Hon'ble High Court, the following candidate is hereby appointed to the post of Driver of Family Court, Koderma in the pay scale 19900-63200 (Level-II) :-



The above said candidate shall have to join within 15 days from the receipt of the appointment letter and for this, no traveling allowance shall be admissible. At the time of joining, the candidate shall have to produce original Residential Certificate, Medical Certificate issued by Civil Surgeon, Sadar Hospital, Koderma along with **Visual Acuity and Colour Vision Test Report** issued by the Eye Specialist, Sadar Hospital, Koderma, Caste Certificate, Educational Certificate and Date of Birth Certificate. The joining shall

be accepted only after scrutiny of the documents produced by the candidate. Unmarried selected candidate shall have to submit Affidavit for not taking and giving dowry. The appointment shall be purely on temporary basis and the services of such candidate can be terminated any time if he is found furnishing false information and necessary legal proceeding shall also be initiated against him. Office is directed to issue Appointment Letter to the selected candidate.

Office Order No. 194/2023 dated 20.10.2023 is hereby modified to that extent only in respect to final result for the appointment of Driver, Family Court, Koderma. The above named Shri Deepak Kumar be informed accordingly .
