(1) The internal complaint committee shall ensure time bound treatment of complaints received from the victims and shall complete inquiry within a period of 90 days as per section 11 (4) of the Sexual Harassment of Women at work Place (Prevention, Prohibition and Redressal) Act-2013 and submit report within 10 days from the date of completion of inquiry as per section 13 (1) of the Act.

(2) The internal complaint committee shall in each calendar year prepare an annual report and submit the same to the undersigned before the **15th March** of the every calendar year as per the section 21(1) of the Act.

(3) The member appointed from amongst NGO or associations shall be paid such fees or allowances for holding the proceedings of the Internal complaint Committee as may be prescribed for the particular complaint by the under signed. The fees or allowances shall be paid to such member only on successful completion of inquiry by the Internal Complaint Committee and submission of its report to undersigned as per section 11(4) and Section 13(1) of the Act.

(4) The committee shall strictly follow the provisions of Sexual Harassment of Women at work Place (Prevention, Prohibition and Redressal) Act-2013.

Any aggrieved Women may make a complaint of Sexual Harassment at Workplace to the internal Complaint Committee (ICC) through online by sending the complaint on email ID (vishi.cj@gmail.com) of Smt. Vaishaly Srivastava (Presiding officer of Internal Complaint Committee, Chief Judicial Magistrate, Koderma.
