The new appointees are directed to give an undertaking before the Presiding Officer at the time of their joining in the shape of affidavit duly attested by a Judicial magistrate 1<sup>st</sup> class to the effect that in case any adverse report about his/her character antecedents is received from the inspector general of police, CID Jammu & Kashmir in that event his/her appointment shall be deemed to be cancelled ab-initio and shall have no claim on his/her appointment.
- v. The salary of the new appointees shall not be drawn unless a satisfactory report in respect of (ii), (iii) and (iv) above is received from the concerned issuing authorities.
