

Office Clerks of transferor Courts are directed to firstly transfer the entire records on CIS and there after hand over entire records, registers etc of concern Police Stations physically to the transferee Courts and also to prepare their charge report in triplicate and submit a copy of the same to Administrative Office.

On order to avoid any discrepancy in G.R. number and Pre-trial number/CIS Number, it is, hereby further ordered that New F.I.Rs of all the Police Stations shall be firstly submitted by the concerned Police Stations in the Office of C.J.M., Siwan (G.R. Office) and G.R. Clerk after mentioning G.R. Number on the F.I.R. shall get the same Registered on CIS and thereafter the F.I.Rs shall be sent to the Courts concerned.

***This Order shall come in force with immediate effect.***

Let a copy of this order be sent to the Superintendent of Police, Siwan for necessary direction to S.H.Os of all the Police Stations as well as to the Jail Superintendent, Siwan for information and needful. Inform all concerned.
