- **2**. Sub-Clause No. 2 of Clause No. 17 of Work Distribution Order No. 187 dated 29-08-2024 is deleted and new Sub-Clause No. 2 of Clause No. 17 is establish as follows:-
- 2. Civil Suit where Claim in suit exceeds 5,00,000 (Five Lakh) but does not exceed 1,00,00,000/- (One Crore) and Connected Executions & Miscellaneous Proceedings . (Institution period October to March)
- 3. Word mentioend "Teh. Mohkhed" in Column no. 3 of Clause No. 26 of Work Distribution Order No.187 dated 29-08-2024 is deleted and new word "Teh. Chhindwara/Mohkhed" is establish on that place.
