The validity of Wait List shall be as per rule.

The Candidates at the time of Joining should bring all their original educational documents along with two self attested copies including original Caste/ Domicile/ P.H certificate as required, duly issued by the competent authority of the State of Jharkhand and a Medical Fitness Certificate issued from the Civil Surgeon/Civil Assistant Surgeon of any Government Hospital, at the time of their joining and the Selected Candidates shall also submit an Affidavit to the effect that he/she shall not accept/offer any dowry in future at the time of his/her marriage and



to the effect that documents submitted by him are genuine and he/she has not been convicted by any Court of Law nor any criminal case is pending against him/her in any Court of Law.

No objection certificate from the employer if working in Government Department or Public undertakings shall also be submitted at the time of Joining.

No TA/DA shall be admissible to the newly appointed candidates.


