

**DISTRICT LEGAL SERVICES AUTHORITY, GIRIDIH**  
Selection committee and Monitoring and Mentoring Committee

Under the provisions of Regulation Act NALSA (Free and competent Legal Services) Regulation 2010 (as amended vide notification F.NO.L61/10/NALSA DATED 22.10.2018) the Panel Lawyers prepared under rule 8; sub-regulation (2) shall be re-constituted after a period of three years.

The last reconstitution of the Panel was done on 29.01.2022 vide Memo No. 94A, Dated 29.01.2022 of the office of Pr. Distt. & Session Judge Cum Chairman DLSA, Giridih. For the smooth functioning of DLSA and as per rule 8; sub-regulation (2) of NALSA (Free and competent Legal Services) Regulation 2010 a selection committee and Monitoring and Mentoring Committee was formed for the purpose of selection/Recantation/Renewal of Panel of Panel Lawyers, DLSA, Giridih.

For the purpose of reconstitution of Panel of Panel Lawyers a meeting of the committee and Monitoring and Mentoring Committee was held at the Chamber of Pr. DIST.& Sessions Judge cum Chairman, DLSA, Giridih on 16-01-25, it was resolved by the Selection Committee in the said meeting to approve enlist the Panel Lawyers in Panel of DLSA, Giridih, who have assured to work in DLSA, Giridih in the light and spirit of the Legal Services Act.

Therefore, a fresh reconstituted list of 98 ( Ninety Eight) Legal Service Lawyers as Panel Advocates and who also volunteer to render Legal Services as per the assignment and requirement of DLSA is hereby prepared/finalized for the purpose of streamlining the Legal Services administration in the DLSA, Giridih, which are mentioned hereunder:
