**ORDER**

No.- 67

Dated: Calcutta, the 26<sup>th</sup> Day of February, 2024

As per Notification No. 251-Emp. dated 3<sup>rd</sup> December, 2013 issued by the Labour Department, Government of West Bengal [Para No. 11) Undertaking], a person appointed on compassionate ground under West Bengal Scheme for Compassionate Appointment, 2013 must give an undertaking initially and every year thereafter by 15th January, in writing that he will properly maintain the other family members who were dependent on the Government employee in question and in case it is proved subsequently at any time that the family members are being neglected or are not being maintained- properly by him/her, service may be terminated for violation of such undertaking following the procedure in West Bengal Services (Classification, Control and Appeal) Rules, 1971. Such yearly declaration should contain an undertaking signed by all the dependent family members that they are being maintained by the person so appointed on compassionate ground to the utmost satisfaction and there is no complaint in this regard. It has come to my knowledge that most of the employees appointed on compassionate ground in the Judgeship of City Sessions Division, Calcutta have not furnished undertaking till now which is tantamount to violation of above stated rule.

In view of the above, all the employees appointed on compassionate ground in the Judgeship of City Sessions Division, Calcutta, are hereby directed to furnish such undertaking in writing that he/she is properly maintaining the other family members who are dependent on ~~the~~ him/her positively within the end of this month and thereafter by 15th January of every year without fail and in case it is proved subsequently at any time that the family members are being neglected or are not being maintained- properly by him/her, service may be terminated for violation of such undertaking following the procedure in West Bengal Services (Classification, Control and Appeal) Rules, 1971.

Head Clerks/Accountants of all the three establishments of this Judgeship are directed to provide data of all the employees appointed on compassionate ground under the Judgeship of City Sessions Division, Calcutta. A register containing the names of such employees appointed on compassionate ground and details of the dependent family member(s) of such employees as provided by the employees, be opened and updated every year.


