It has been observed that none of the existing Legal Aid Counsels (LACs) are practicing exclusively at Lakhipur Sub-Divisional Courts, Cachar and therefore, the Legal Aided Cases of non-criminal nature (Civil Cases & DV Act Cases) of Lakhipur Sub-Divisional Courts are not getting proper attention as the existing LACs have their practice base at Silchar and the same is causing inconvenience to both the litigants and the existing LACs. Hence, it is imperative to engage 02 (two) fresh LACs **exclusively for Lakhipur Sub-Divisional Courts** to deal with **Legal Aided Civil Cases as well as Cases under the Protection of Women from Domestic Violence Act, 2005** from amongst the eligible Advocates, who are having their practice base at Lakhipur Sub-Divisional Courts.

Keeping in mind the above objective, fresh applications are invited from the eligible Learned Members of the District Bar Association and Advocates' Bar Association, Cachar, Silchar, who are willing to serve as Legal Aid Counsel (LAC) **exclusively at Lakhipur Sub-Divisional Courts** under the District Legal Services Authority, Cachar, Silchar for a period of **01 (one) year** from the date of appointment or until further order, whichever is earlier.

Eligibility Criteria:

- (i) Minimum 03 (three) years of experience at the Bar having his/her practice base at Lakhipur Sub-Divisional Courts &
- (ii) He/she should have the competence, integrity and suitability for working in the interest of the poor and the needy.

Applications along with the applicant's bio-data, being duly forwarded by the President/Secretary of the District Bar Association/Advocates' Bar Association, Cachar in the prescribed format, should reach the office of the undersigned on or before **02/04/2024** (during office hour).
