2. The candidate must not be less than 18(eighteen) years and not more than 40 years of age as on **01.01.2024**. Relaxation of age will be as per Govt. norms.

Application must be accompanied with self attested photocopies of all the testimonials regarding **educational qualifications, age, caste, valid employment exchange registration card, special skills & experience certificate (if any)** along with three copies of recent passport size colour photographs duly signed by the candidate out of which one shall be pasted in the application and the rest two should be stapled in the top right corner of the application form. **Candidates to provide his/her mobile No./WhatsApp No. in the form.** Application must submit self addressed envelope affixing postage stamp of Rs.5/-. Application should reach the office of the undersigned on or before 27th August/2024 till 05.00 PM.
4. Candidate already serving in the Govt. Department should submit his application through proper channel.

10. The selection Board reserves the right to cancel, alter or modify the advertisement or other terms and conditions of the advertisement without any prior notice, which will be notified in the official website.


