#### **HOW TO APPLY :**

The intending candidates will have to submit their application in sealed envelope to "**The Chief Judicial Magistrate, Cachar, Silchar, Pin: 788001**" either personally or through post on or before **04.03.2025** by **5 PM**.

1. The applicants must super scribe "Application for the post of Driver" on the top of the envelope and must write their WHATSAPP MOBILE No. and Email ID on the top of the Standard Form in red ink.
2. The applications must be accompanied with:
  - a) Two Copies of recent passport size coloured photographs.
  - b) Self attested copies of all testimonials in support of educational qualification, Driving License and Employment Registration certificate.
  - c) Experience certificate, if any.
3. Candidates already in Govt. Service must apply through proper channel.

#### **ELIGIBILITY CRITERIA:**

1. The candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The Candidate must have a valid **LMV Driving License** issued by the competent authority. The Driving License must be issued at least 3 years before the date of publication of this advertisement.
3. The candidate must not be **less than 18 years and above 40 years of age**. Age criteria shall be guided by government guidelines and the determinative date shall be 01-01-2025.
4. Minimum Qualification of the candidate must be Class X/ HSLC passed.
5. Preference will be given to experienced candidates.
6. Candidate must possess an Employment Registration certificate issued by the Govt. of Assam.

**SELECTION PROCESS:**

<b>Stage 1</b>	<p style="text-align: center;"><b><u>Screening Test of qualifying nature: 50 marks</u></b></p> <p>Screening Test (Objective Type multiple choices) for 50 marks testing the General Knowledge (20 marks), Knowledge of Traffic Signs and Symbols (20 marks) and English Language (10 marks). The test will be conducted on OMR sheets and the duration will be 1 hour (60 minutes).</p> <p>In order to qualify in the Screening Test, a candidate shall have to secure a minimum of 25 marks out of the total 50 marks.</p> <p>The Screening Test will be of qualifying nature and marks obtained therein will not be considered while preparing the final select list.</p>
<b>Stage 2</b>	<p style="text-align: center;"><b><u>Driving Test: 30 marks</u></b></p> <p>Candidates equal to 5 times of the number of vacancies (1:5) in order of merit in the Screening Test will be called for Driving Test.</p> <p>The Driving Test will be on the segments namely Starting, Driving and Parking (10 marks for each segment totaling 30marks).</p> <p>In order to qualify in the Driving Test, a candidate shall have to secure a minimum of 15 marks out of the total 30 marks.</p>
<b>Stage 3</b>	<p style="text-align: center;"><b><u>Viva-voce: 20 marks</u></b></p> <p>Candidates equal to 3 times of the number of vacancies (1:3) in order of merit in the Driving Test will be called for Viva-voce/Oral Interview.</p> <p>On the basis of sum total of marks obtained in Driving Test and Viva-voce, the final select list will be prepared.</p> <p>Where more than one candidate obtain same grand total marks (marks of Driving Test and Viva-voce), the candidate who obtains more marks in the Driving Test will get preference. Where the marks obtained by such candidates in the Driving Test are also same, the candidate who is senior in age will get preference.</p>

**IMPORTANT INSTRUCTIONS:**

1. The Individual Call Letter will be sent to the eligible candidates through electronic mode i.e. through Whatsapp or Email Id. Accordingly, candidates are mandatorily required to provide their Whatsapp Mobile Number and Email Id as instructed earlier.
2. The candidates are advised to visit the official website of District Judiciary, Cachar (<https://cachar.dcourts.gov.in>) regularly to get updated information or instructions.
3. Canvassing of any forms, either directly or indirectly, by a candidate will lead to disqualification.

4. The candidate will have to appear in the tests and interview at their own expenses and no T.A & D.A. is admissible in this respect.
5. Candidates will be responsible for any mistakes made by him/her in the application form. Incomplete or incorrect application will be summarily rejected.
