Sri Bhagwat Mehra, learned Counsel for the petitioner has filed a Misc. correction/modification application no. 64 dated 27/03/2025 to correct/modify the judgment and order dated 21.03.2025, passed in Claim Petition No.24/NB/DB/2024, Omkar Nath Kosta Vs. State of Uttarakhand and others, stating therein that the concerned office memo dated 15.04.2008 issued by the respondent no. 1 was challenged only 'in so far as it relates to non-certification of integrity of the petitioner for the year 2003-04'. Although, the said prayer is correctly reproduced in Page No. 1 of the judgment dated 21.03.2025, however, in the last operative portion of the judgment dated 21.03.2025, at page no. 9 last portion, the entire office memo dated 15.04.2008 has been quashed/set aside due to inadvertent typographical error. As such, it is prayed that the judgment dated 21.03.2025 be modified/corrected to this extent i.e. quashing of office memo dated 15.04.2008, in so far as it relates to non-certification of integrity of the petitioner for the year 2003-04.

Learned A.P.O. has also agreed to the above submission of learned Counsel for the petitioner.

Hence, the correction/modification application is allowed, in the interest of justice. Accordingly, last portion of the judgment dated 21.03.2025 is modified/corrected, as prayed. The modified portion is as under:

".....The impugned orders dated 07.02.2023 and 05.12.2023 are liable to be quashed \*and office memo dated 15.04.2008 so far as it relates to non-certification of integrity of the petitioner for the year 2003-04 is also liable to be quashed\* and the claim petition is liable to be allowed.

#### **ORDER**

The claim petition is hereby allowed. The impugned orders dated 07.02.2023 and 05.12.2023 are quashed \*and memo dated 15.04.2008, so far as it relates to non-certification of integrity of the petitioner for the year 2003-04 is also quashed\*." The respondents are directed to grant benefit of 1st ACP & 2nd ACP and other consequential benefits to the petitioner accordingly within three months."

This order shall be part of the judgment and order dated 21.03.2025, in Claim Petition No. 24/NB/DB/2024.

Accordingly, the Misc. correction/modification application is disposed of.
