Sri Abhishek Chamoli, learned Counsel for the applicant, submitted that present miscellaneous application has been filed by the

petitioner-applicant for ensuring compliance of order dated 02.03.2022, passed by this Tribunal in Claim Petition No. 31/DB/2022 and subsequent orders dated 21.11.2022 and 10.01.2023 passed respectively in Execution Petition No. 25/DB/2022 and Contempt Petition No. 01/DB/2023, Sri Sandeep Kumar Chauhan vs. State of Uttarakhand and others.

Learned A.P.O., on seeking instructions from the respondent-department, submitted that admissible gratuity of Rs. 3,41,704/- (upto 30.04.2023) has been sent to the Treasury for payment to the petitioner. He further submitted that the same will be credited to the account of the petitioner very soon. Learned A.P.O. further submitted that interest on delayed payment of gratuity has been calculated and a request has been made to Police Headquarters to release the budget.
