JUDGMENT

DATED: JUNE 16, 2025

Justice U.C.Dhyani (Oral)

The Petitioner is retired Principal of Govt. Inter College, Akhodi, Tehri Garhwal. By means of present claim petition, he seeks the following reliefs:

"I) To direct the respondents to release the superannuation pension, gratuity etc. to the petitioner from 1-7-2023 onwards (Annexure No A-1).

II) To direct the respondents to pay the interest on the delayed payment of pension, gratuity etc. @ 12% per annum till the amount is paid.

III) To pass any other suitable order, which the Hon'ble Tribunal may deem fit and proper on the basis of facts and circumstances of the case.

IV) Award the cost of the petition to the petitioner."

2. The claim petition is supported by the affidavit of the petitioner. Relevant documents have been filed along with the same.

3. The claim petition was admitted on 30.12.2024. Notices were issued to the respondents. Time for filing C.A./W.S. was granted to the respondents.

4. Today Sri Dharmendra Singh Rawat, In-Charge Principal, G.I.C. Akhodi, Tehri Garhwal is present in person before the Tribunal. He addressed a letter to Sri V.P.Devrani, Ld. A.P.O., who, in turn has forwarded the same to the Bench.

5. Ld. A.P.O., submitted that petitioner's leave of 230 days has been granted. Now, there is no break in service. The department is ready to prepare petitioner's pension papers, but for that the petitioner will have to come to the office of G.I.C., Akhodi, Tehri Garhwal. Ld. Counsel for the petitioner submitted that petitioner is resident of Agra, Uttar Pradesh. He is ready to come to the office of G.I.C., Akhodi. Ld. Counsel for the petitioner prayed that once the petitioner comes to G.I.C., Akhodi, a direction be given to the respondents to prepare petitioner's pension papers and release his retiral dues.

6. Ld. A.P.O. assured the Bench that the same shall be done as expeditiously as possible, in accordance with law, but submitted that a direction be given to the petitioner to come to office of G.I.C., Akhodi, Tehri Garhwal, only then his pension papers may be processed.

7. Ld. Counsel for the petitioner submitted that petitioner will come to the office of G.I.C., Akhodi, Tehri Garhwal, in the first week of July. Ld. A.P.O. submitted that after completing necessary formalities, petitioner's pension papers will be processed and in all probability, papers shall be handed over to him before 15th August, 2025.

8. The Tribunal records the aforesaid statement of Ld. Counsel for the parties. No useful purpose would be served by keeping the claim petition pending. The petition is, accordingly, closed.

9. Liberty is granted to the petitioner to make oral mention if the things do not proceed as per the above noted plan.
