JUDGMENT

By means of present execution petition, petitionerapplicant seeks to enforce order dated 16.02.2024, passed by this Tribunal in Claim Petition No. 14/SB/2024, Kiran Negi vs. State of Uttarakhand & others.

- 2. The execution petition is supported by the affidavit of Ms. Kiran Negi, petitioner-applicant along with copy of the judgment passed by the Tribunal on 16.02.2024.
- 3. The decision rendered by this Tribunal on 16.02.2024, is reproduced herein below for convenience :
 - "By means of present claim petition, petitioner seeks to direct the respondents to decide the representation dated 21.12.2023 (Annexure: A-6) of the petitioner, as per law.
 - 2. Petitioner moved a representation dated 21.12.2023 (Annexure: A-6) to Additional Director General of Police (Admin.) for granting her out-of-turn promotion. In her representation, she has stated that she earned Silver Medal for Uttarakhand Police in Senior National Judo Championship 2009-10, without getting any reward. Whereas Sri Lokesh Sharma, who earned Silver Medal for Uttarakhand Police in National Volleyball Championship has been given out-of-turn promotion in the year 2017, petitioner has not been given such promotion.
 - 3. Ld. Counsel for the petitioner submitted that the only prayer of the petitioner, in this claim petition, is to direct Respondent No.2 to decide pending representation of the petitioner, as per law. Ld. A.P.O. has no objection to such innocuous prayer of Ld. Counsel for the petitioner.
 - 4. Ld. counsel for the parties submitted that such an order can be passed by Single Bench of the Tribunal.
 - 5. The claim petition is disposed of, with the consent of Ld. counsel for the parties, by making a request to Respondent No.2 to decide pending representation of the petitioner by a reasoned and speaking order, as per law, without unreasonable delay, preferably within 12 weeks of presentation of certified copy of this order along with copy of representation, enclosing the documents in support thereof. No order as to costs.
 - 6. It is made clear that the Tribunal has not expressed any opinion on the merits of the case.
 - 7. Rival contentions are left open."
- 4. Ld. Counsel for the petitioner submitted that copy of judgment dated 16.02.2024 was supplied by the petitioner to Respondent No.2 on 16.02.2024 (Annexure: E-2). It is also the submission of Ld. Counsel for the petitioner that the said order of the

Tribunal has become final as no review petition has been filed by the

respondent department against the same, but till date order dated

16.02.2024 has not been complied with by the authority concerned. Ld.

Counsel for the petitioner further submitted that casual approach on

the part of opposite party(ies)/respondent(s) should not be tolerated

and strict direction should be given to them to ensure compliance of

such order

5. The execution petition is disposed of, at the admission

stage, with the consent of Ld. Counsel for the parties, by directing the

Respondent No.2, to comply with the order of the Tribunal dated

16.02.2024, passed in Claim Petition No. 14/SB/2024, Kiran Negi vs.

State of Uttarakhand and others, if the same has not been complied

with so far, as expeditiously as possible and without unreasonable

delay on presentation of certified copy of this order, failing which the

concerned authority may be liable to face appropriate action under the

law governing the field.
