By means of present claim petition, petitioner seeks the following reliefs:

- "I. To issue an order directing the respondent number 2, 3, and 4 to take decision on the representation of petitioner in the light of government order dated 25/10/2000.
- II. To give any other relief that this Hon'ble Tribunal may deem fit and proper in the circumstances of the case.
- III. Award the cost of the petition."
- 2. The claim petition is supported by the affidavit of the petitioner. Relevant documents have been filed along with the same.
- 3. Petitioner, in her claim petition has narrated the facts giving rise to present claim petition. She has stated in her petition that a writ petition being WPSS No. 1502/2025 was filed before the Hon'ble High Court. The same was withdrawn on 24.02.2025, as her grievance thus raised was redressed, but she was not given promotion since the date of her eligibility dated 04.04.1999. Petitioner has filed present claim petition for limited prayer of giving promotion since 04.04.1999.
- 3.1 Sri S.C. Yadav, Ld. Counsel for the petitioner submitted that petitioner has filed various representations but no decision has been taken on the same as per law. Petitioner's only prayer, in present petition is, to direct the respondents to take a decision on her representation in the light of Govt. Order dated 25.10.2000.
- 4. Ld. A.P.O. has no objection to such innocuous prayer of Ld. Counsel for the petitioner, if a direction is given by the Tribunal to respondents to take a decision on the pending representation of the petitioner, as per law.
- 5. The claim petition is disposed of, at the admission stage, with the consent of Ld. Counsel for the parties, by directing the competent authority, to decide representation of the petitioner by a reasoned and speaking order, as per law, as expeditiously as possible, and without unreasonable delay on presentation of certified copy of this order, along with copy of

representation, enclosing the documents in support thereof. No order as to costs.
