JUDGMENT

By means of present claim petition, petitioner seeks the following reliefs:

"(i) To direct the respondent No.4/SSP Haridwar to release all the service benefits, refix the pay and pension of the petitioner in view of the setting aside the punishment of "Censure" dated 5-7-1995 by the respondent No.3/IGP Garhwal Range vide order dated 5-5-2025(Annexure No. A-1 colly)

- (ii) To pass any other suitable order, which the Hon'ble Tribunal may deem fit and proper on the basis of facts and circumstances of the case.
- (iii) Award the cost of the petition to the petitioner."
- 2. The claim petition is supported by the affidavit of petitioner. Relevant documents have been filed along with the same.
- 3. Petitioner is retired Sub-Inspector (Special Category), who was working in the Police Department. When he was in service, he was given 'censure entry'. He preferred departmental appeal against the same. The appellate authority, *vide* order dated 05.05.2025, allowed the appeal and set aside the punishment order dated 05.07.1995 given by the then Senior Superintendent of Police, Dehradun.
- 4. In a nutshell, 'censure entry', which was awarded to the petitioner by the disciplinary authority, has been set aside by the appellate authority.
- 5. Petitioner has made a representation on 11.09.2025, followed by reminder dated 28.10.2025 to the SSP, Haridwar, to refix his pay, pay the arrears and further to refix the pension and pay the arrears thereof, from the date of retirement.
- 6. Petitioner has also given a representation for striking out the 'censure entry' from his ACR.
- 7. Both the representations/applications are pending consideration of the authority concerned.
- 8. It is the submission of Ld. Counsel for the petitioner that when petitioner's censure entry has been set aside by the appellate authority, the petitioner is entitled to all the dues, including retiral dues along with arrears on those dues. In reply, Ld. A.P.O. submitted that, if the dues of the petitioner, including retiral dues and arrears thereof have been withheld on account of 'censure' entry, then the respondent department shall pay the admissible dues to the petitioner.

with the consent of Ld. Counsel for the parties, by directing Respondent

No.4, to decide the pending representation(s) of the petitioner in the light

of the above, as expeditiously as possible, and without unreasonable

delay on presentation of certified copy of this order, along copy of

representation, enclosing the documents in support thereof. No order

as to costs.
