JUDGMENT

Justice U.C. Dhyani (Oral)

By means of present claim petition, petitioners seek the following reliefs:

- "I. To issue an order or direction to set aside the impugned final seniority list dated 18.08:2023 passed by the respondent no. 2 (Annexure No. A-1 to the claim petition).
- II. To issue an order or direction to the respondent no. 2 to place the claim petitioners in the same position as it was in the Tentative

Seniority List of Junior Engineer (Civil) issued vide Office Memorandum dated 30.07.2022 issued by the respondent no. 2 (Annexure No. A-5 to the claim petition).

- III. To give any other relief that this Hon'ble Tribunal may deem fit and proper in the circumstances of the case.
- IV. Award the cost of the petition."
- 2. Claim petition is supported by the affidavit of Sri Amit Singh Rawat, Petitioner No.1. Relevant documents have been filed along with the petition.
- 3. Claim petition has been contested on behalf of respondents. C.A. has been filed by Sri Manish Kumar Ingle, Dy. General Manager (Personnel), UJVNL, Ujjwal Maharani Bagh, GMS Road, Dehradun, on behalf of Respondent No. 2. Relevant documents have been filed in support of Counter Affidavit. Ld. A.P.O. adopted the same Counter Affidavit for Respondent No.1, which has been filed on behalf of Respondent No. 2. There is no representation for private respondents.
- 4. Rejoinder Affidavit has been filed on behalf of petitioners.
- 5. UJVNL, Respondent No.2 was assigned the task to serve notices upon private respondents, which Respondent No.2 has done. Affidavit of service has been filed by Respondent No.2 along with the report of Sri Ashish Kumar Jain, Executive Director (HR), showing that private respondents have been served with notices. Copies of the individual notices have been filed along with the report.
- 6. Office Memorandum dated 18.08.2023 (Annexure-1) is impugned in present claim petition. This is final *inter se* seniority of Junior Engineers (Civil). The names of the petitioners have been shown from SI. No. 52 to 77 in the said final seniority list. Before that a tentative seniority list was issued by the Respondent Corporation on 30.07.2022 (Annexure- 6). The names of the petitioner have been shown from SI. No. 36 to 66 in the said list.
- 7. Since the petitioners were shown from SI. No. 36 to 66 in the tentative seniority list, they were probably satisfied with the same,

therefore, there was no question of filing objections against the tentative seniority list by them. They were taken by surprise when the final seniority list dated 18.08.2023 (Annexure-1) came to their notice. Being aggrieved with the same, present claim petition has been filed for redressal of their grievances.

- 8. Since the effect of impugned final seniority list (Annexure-1) continues even today, therefore, it cannot be said that the claim petition is barred by limitation.
- 9. Dr. N.K.Pant, Ld. Counsel for Respondent No.2, drew attention of the Tribunal towards C.A. filed on behalf of Respondent No.2, to submit that in the provisional seniority list, the candidates selected through different notifications of the year 2015 and 2016 were erroneously shown together on the basis of merit, therefore, the same required correction. Dr. Pant also submitted that selection was made in the same selection year, apparent mistake was found in the provisional seniority list, therefore, the same was corrected.
- 10. Dr. Pant further submitted that the final seniority list was prepared under the "Uttar Pradesh State Electricity Counsil Seniority Regulations, 1998", as applicable to Uttarakhand, according to which "Persons appointed as a result of subsequent selection shall be junior to persons appointed as a result of previous selection."
- 11. In reply, Ld. Counsel for the petitioners drew attention of the Bench towards the R.A. filed, to submit that letter dated 18.08.2023 has adversely affected the petitioners. The provisional seniority list was issued in favour of the petitioners, therefore, it was incumbent upon the respondents to provide an opportunity of hearing to the petitioners before issuing letter dated 18.08.2023, especially when their names were shown from Sl. No. 36 to 66 in the tentative seniority list and in the final seniority list, their names have been lowered down from Sl. No. 52 to 77.
- 12. The Tribunal finds sense in such argument of Ld. Counsel for the petitioners. When the petitioners were shown from Sl. No. 36 to 66

in the tentative seniority list dated 30.07.2022 (Annexure-6), their

seniority should not have been lowered down while issuing final

seniority list on 18.08.2023 (Annexure-1), without notice to them. It has

already been pointed out above that had the petitioners been aggrieved

with the tentative seniority list, only then they would have filed objections

against it. Probably they were satisfied with that, therefore they had no

occasion to file objections against the same. Why should the petitioners

object to the tentative seniority list when their names were shown above

the private respondents in the said tentative seniority list? Their

grievance arose only when they found that they have been placed at

from SI. No. 52 to 77 in the final seniority list, that too, without any notice

to them. Private respondents have not appeared before the Tribunal to

contest the petition.

13. In substance, the impugned seniority list dated 18.08.2023

(Annexure-1) cannot sustain qua petitioners only, inasmuch as no

notice was given to them before changing their seniority to their

detriment.

14. Seniority list dated 18.08.2023 (Annexure-1) is, therefore, set

aside only in respect of the petitioners. Respondent Corporation is

directed to afford reasonable opportunity of hearing to the petitioners

before placing them appropriately in the final seniority list. The same

shall be done as expeditiously as possible, without unreasonable delay.

15. The claim petition thus stands disposed of. No order as to

costs.
