JUDGMENT

Justice U.C.Dhyani (Oral)

By means of present claim petition, petitioner seeks the following reliefs:

- “i) To quash the impugned final seniority list dated 12.12.2024 (Annexure No. A-1) and provisional seniority list dated 07.11.2024 (Annexure No. A-3) with its effect and operation.
- ii) To declare that the petitioner is senior to the private respondent and other person s of the impugned seniority list and therefore entitled to place above to them in the seniority list of Office Assistant-First.
- iii) To issue an order or direction to the concerned respondent (respondent department) to redraw and prepare the fresh seniority list of Office Assistant First and determine the inter-se seniority of petitioner and private respondents & other on the basis of their appointment in the feeding cadre post of conductor.
- iv) To issue any other order or direction which this court may deem fit and proper in the circumstances of case in favour of the petitioner.
- v) To award the cost of petition.”

2. Sri Vaibhav Jain, Ld. Counsel for Uttarakhand Transport Corporation, on seeking instructions from Dy. General Manager (Law) Uttarakhand Transport Corporation, submitted that the seniority list has been prepared as per the direction dated 27.04.2019 of the Hon'ble High Court in WPSB No.519/2016, Ganga Prasad and others vs. State of Uttarakhand and others. He further submitted that this petition has rendered infructuous.

3. In reply, Ld. Counsel for the petitioner also submitted that the Managing Director, Uttarakhand Transport Corporation has prepared seniority list as per the direction of the Hon'ble High Court.

4. The Tribunal has noted the aforesaid statements of Sri L.K.Maithani & Sri R.C.Raturi, Ld. Counsel for the petitioner and Sri Vaibhav Jain, Ld. Counsel for Respondent No.2 & 3.

5. In view the above submissions, the Tribunal feels that no useful purpose would be served by keeping the claim petition pending. The claim petition has rendered infructuous. The same is dismissed as infructuous. No order as to costs.
