JUDGMENT

DATED: DECEMBER 05, 2025

Justice U.C.Dhyani (Oral)

By means of present claim petition, petitioners have made an innocuous prayer that the respondent authorities may kindly be directed to decide petitioners' representation dated 03.11.2025 (Annexure: 2), as per law, in a time bound manner.

2. The claim petition is supported by the affidavit of Sri Bhanu Prakash, Petitioner No.1. Relevant documents have been filed along with the same.

3. Interim prayer has also been sought that till the time the decision is taken, operation of the report dated 10.10.2025 (Annexure-8) be kept in abeyance, to the extent the same is prejudicial to the petitioners.

4. Ld. A.P.O. objected that the interim order, if any, cannot be given by the Tribunal unless, at least 14 days' time to file objections on the interim relief is given to the respondents, in terms of Section 5 (5-A) (b) of the U.P. Public Services (Tribunal) Act, 1976 (as applicable to Uttarakhand). In reply, Sri S.S.Yadav, Ld. Counsel for the petitioners submitted that petitioners are not pressing interim relief, as of now, but insist and request that their representation may kindly be directed to be decided by the competent authority, in accordance with law, to which Ld. A.P.O. has no objection.

5. Since it is an innocuous prayer, private respondents are not issued notices.

6. Sri S.S.Yadav, Ld. Counsel for the petitioners submitted that an opportunity of personal hearing may kindly be given by the competent authority to the representative of delegation of the petitioners, before taking an appropriate decision on their representation, as per law.

7. The claim petition is disposed of, at the admission stage, with the consent of Ld. Counsel for the parties, by making a request to Respondent No.1, to decide pending representation of the petitioners after affording opportunity of personal hearing to the representative of delegation of petitioners, as also the representative of delegation of private respondents, in a time bound manner, in accordance with law, on presentation of certified copy of this order in the offices of official respondents.

8. This order is being passed without prejudice to any of the judgments/ orders passed by any Court or Tribunal relating to *inter-se* seniority of the Lecturers working in the respondent department or any other pending matter relating thereto.

9. It is made clear that the Tribunal has not expressed any opinion on the merits of the case. Rival contentions are left open.
