### **JUDGMENT**

**DATED:JANUARY 02, 2026**

The petitioners have filed this claim petition for the following reliefs:

*“(i) To issue appropriate direction directing the respondents forthwith pay the arrears of the 7th pay commission w.e.f. 01-01-2016 alongwith 18% pursuant to the directions of the Hon'ble Apex Court dated 12-02-2020 passed in Civil Appeal Nos. 1486-1487 of 2020 (SLP(C) Nos. 11651-11652 of 2019) Uttaranchal Van Shramik Sangh Ranibagh and others Vs/ The State of Uttarakhand and others (Annexure No.1 to the claim petition) or in alternate pass any other order direction which this Hon'ble court may deem fit and proper under the facts and circumstances stated in the body of the claim petition.*

*(ii) To issue any other order or direction which this Hon'ble Court may deem fit and proper in the circumstances of the case.”*

2. Learned Counsel for the petitioners submitted that the petitioners are the employees of the forest department and some of the petitioners are retired from service and some of the petitioners are still

working in the department and their service were regularized pursuant to the judgment of the Hon'ble Apex Court in Putti Lal case, in which, it has been held that the members of the Kumaon Ban Shramik Sangh were being paid DA on a regular basis as per the judgment rendered by the Allahabad High Court in Writ Petition No. 15627 of 1988. the petitioners who were engaged by the erstwhile state of U.P. on the daily wages are the members of the Kumoun Ban Shramik Sangh and after the creation of the State of Uttarakhand their services were transferred to state of U.P. It is submitted that despite the aforesaid judgment of the Hon'ble Apex Court, the respondent department was discriminating the employees of the department who are working in daily wages and not paying the D.A. Aggrieved by the said action of the respondents the Union as well as individuals persons approached the Hon'ble Apex Court and after the intervention of the Hon'ble Apex Court the employees like the petitioners were paid the D.A. along with minimum pay scale and also granted the benefit of the 6<sup>th</sup> pay commission along with their counter parts working on regular basis. It is further submitted that when the 7<sup>th</sup> pay commission was implemented in the department the respondent department again discriminated the daily wagers like the petitioners then the Union again approached the Hon'ble Apex Court by way filing the Civil Appeal Nos. 1486-1487 of 2020 (SLP(C) Nos. 11651-11652 of 2019) Uttaranchal Van Shramik Sangh Ranibagh and others Vs/ The State of Uttarakhand and others and the Hon'ble Apex Court after hearing parties passed the following judgment:

*“We are in agreement with the claim of learned counsel that in view of the judgment referred to aforesaid the minimum of the pay-scale as is defined is with reference to the counter parts in the Government holding the Government posts. Thus, if the 7<sup>th</sup> Pay Commission is implemented (as is conceded) qua the regular employees, the workers like the appellants would be entitled to the minimum of the pay-scale of those regular Government employees of the Group D posts.”*

The respondent department after the above judgment and after filing the contempt petition before the Hon'ble Apex Court, allowed the benefit of the 7<sup>th</sup> pay commission w.e.f. the date of the judgment i.e. 12-02-2020, but did not pay the arrears of the same w.e.f. 01-01-2016.

3. After hearing learned Counsel for the petitioners to some extent, he confined his prayer to the extent that he will move a detailed fresh

representation to the Respondent no. 1, stating all the relevant facts, mentioned in the claim petition, which may kindly be directed to be decided by the Respondent no.1 (State of Uttarakhand through Principal Secretary, Forest, Dehradun) within a stipulated time, by a reasoned and speaking order.

4. Learned A.P.O. has no objection to the innocuous prayer of learned Counsel for the petitioners.

5. In view of the above, the petitioners shall move a detailed fresh representation to the Respondent no.1(State of Uttarakhand through Principal Secretary, Forest, Dehradun) within 15 days and the Respondent no.1 shall decide the representation of the petitioners by a reasoned and speaking order within three months, from the date of presentation of certified copy of this order along with representation.

6. Accordingly, the claim petition is disposed of, at the admission stage. No order as to costs.
