**JUDGMENT**

**DATED: JANUARY 21.2026.**

**Justice U.C. Dhyani (Oral)**

By means of present claim petition, the petitioner seeks the following reliefs:

*"a. Issue an order or direction to respondent No.2 (UPNL) to reinstating the claimant at his post/service and direct payment of all*

*arrears of salary, wages, allowances, and consequential benefits from 21.10.2024 till the date of actual reinstatement, along with interest at 9% per annum.*

*b. Issue an order or direction for quashing the department order dated 21.10.2024 passed by respondent No.3 (annexed as annexure No4jand consequently direct reinstatement of the Petitioner to his post/service with full dignity, continuity, and all consequential benefits including back wages.*

*c. Issue any other relief which this Hon'ble Tribunal may deem fit and proper in the circumstance of the case be passed in the favor of claimant."*

2. Ld. A.P.O. objected that the claim petition is not maintainable before the Tribunal. According to him, the petitioner is a 'workman' and he can file his petition only before the Labour Court and not before this Tribunal.

3. Conceding the said fact, Ld. Counsel for the petitioner seeks to withdraw the claim petition with liberty to file the same before the appropriate forum, having jurisdiction.

4. Claim petition is disposed of as withdrawn, with liberty to the petitioner to file the same before the appropriate forum, having jurisdiction.

5. Ld. Counsel for the petitioner prayed that the documents filed with the claim petition be returned to him for presentation before the proper forum.

6. Such prayer is allowed. Let the documents enclosed with the petition be returned to the petitioner, as prayed. Skeleton file be retained in the Tribunal.
