**JUDGMENT**

**DATED: JULY 06, 2026**

Present claim petition has been filed by the petitioners for the following reliefs:

*“(i) To issue order or direction appropriate in nature and set aside the impugned order dated 27-02-2024 (Annexure No.1) and declared the government order dated 11-05-2006 is running contrary to the judgment of the Hon'ble Allahabad High Court in writ petition no. 62797 of 2012” C.P. 1601 Sudip Kumar and others Vs.*

*State of Uttar Pradesh and others" and further direct the respondents to pay the full salary of the training period along with admissible interest after calling the entire records or in alternate pass any appropriate orders keeping in view of the facts highlighted in the body of the petition or mould the relief appropriately.*

*(ii) To issue any other order or direction which this Hon'ble Court may deem fit and proper in the circumstances of the case."*

2. During pendency of the claim petition, Misc. Application, supported with an affidavit, has been filed on behalf of the petitioners mentioning therein that the respondents have denied the relief claimed by the petitioners on the ground of the judgment of the Hon'ble High Court and Hon'ble Supreme Court by way of filing Counter Affidavit. It is also submitted that the petitioners made a representation to the Chief Sectary, Secretary, Home and DGP, Uttarakhand Police on 08.09.2025 for giving them notional pay increments. On the representation of the petitioners the Under Secretary, Govt. of Uttarakhand vide its letter dated 17.09.2025 requested to the DGP, Uttarakhand Police to send the proposal to the Government about the anomaly in the pay of the petitioners.

3. Pursuant to the letter dated 17-09-2025 the I.G. P.A.C. Uttarakhand Police vide its letter dated 06.10.2025 directed the commandant 46 Battalion P.A.C to send proposal in respect of the petitioners. The commandant directed the petitioners to submit a detail representation by mentioning all the relevant papers and facts. The petitioners submitted the representation on 14-11-2025 and commandant 46 Battalion P.A.C forwarded the same to the I.G. Karmik, Uttarakhand Police and requested to send the proposal to the government. More than 6 months have elapsed, but till date the Police Headquarters has not sent the proposal to the Govt. and no final decision has been taken on the matter of the petitioners.

4. Now the petitioners have confined their prayers only to the extent that the respondents may be directed to consider the

pending representations of the petitioners, in a time bound manner, in accordance with law. No other reliefs have been pressed on behalf of the petitioners. Learned A.P.O. has no objection, if a direction is given to the respondents to decide the representation of the petitioners.

5. In view of the above, the Tribunal directs the respondents to consider and decide the pending representation dated 14.11.2025 (Annexure-4) of the petitioners, which is addressed to Inspector General of Police, Karmik, Police Headquarters, Uttarakhand, Dehradun within a period of two months of production of certified copy of this order, by a reasoned and speaking order.

6. With the above directions, the claim petition is disposed of. No order as to costs.
