JUDGEMENT

Present execution application has been filed to secure the compliance of Tribunal's order dated 10.05.2024, passed in claim petition no. 34/SB/2024, Sri Raghunath Singh Rawat vs. State of

Uttarakhand and others. Relevant paragraphs of the said judgement read as under:

“

6. The prayer of learned Counsel for the petitioner, at this juncture, is to direct Chief Education Officer, Pauri Garhwal, to take prompt action on letter dated 13.03.2024 of Additional Director, Secondary Education, Garhwal Mandal, Pauri.

7. In a nutshell, the submission of learned Counsel for the petitioner is that G.P.F. amount along with interest, as has been mentioned in the calculation memo appended to the letter of Additional Director, Secondary Education, Garhwal Mandal, Pauri, which has been addressed to Chief Education Officer, Pauri Garhwal, be released to him.

8. In reply, learned A.P.O. submitted that if the amount has not been released in favour of the petitioner, the same may kindly be directed to be released, in accordance with law.

9. Claim petition is disposed of, at the admission stage, by directing Chief Education Officer, Pauri Garhwal, to take action on the letter dated 13.03.2024 of Additional Director, Secondary Education, Garhwal Mandal, Pauri, at the earliest, as per law, without unreasonable delay, preferably within eight weeks of presentation of certified copies of this order to Chief Education Officer, Pauri Garhwal and Principal, Janta Inter College, Devrajkhali, Pauri Garhwal enclosing the documents in support thereof. No order as to costs.”

2. The execution application is supported by the affidavit of Sri Raghunath Singh, petitioner. Relevant documents have been filed in support of execution application.

3. It is the submission of learned Counsel for the petitioner that respondent authorities have not done anything to secure the compliance of Tribunal's order dated 10.05.2024 and casual approach on the part of said authorities should not be tolerated, strict action should be taken against them.

4. Considering the facts of the case and after hearing learned Counsel for the parties, the Tribunal deems it appropriate to pass the following order.

5. The execution application is disposed of, at the admission stage, by directing the authorities concerned to ensure compliance of Tribunal's order dated 10.05.2024 and file compliance affidavit within four weeks of presentation of certified copy of this order along with documents in support thereof, failing which they may be liable to face action for non-compliance of Tribunal's order under the relevant law governing the field.
