- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. - L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

B. General Terms and Conditions.

1. Right to reject all bids

The authority reserves the right to accept/reject and cancel a ny bid.

- 2. **Terms of delivery**. Delivery of materials and installation work will be done in the working hours and within the knowledge of Engineer I/C.
- 3. Scope of work: -
 - Ø Supplier will do the supply, Installation, Testing and commissioning of the new Elevator as per specification agreed. Safety barricades, material shifting, Scaffolding, painting works, Minor civil works.
 - Ø Finalization of location of lift shaft/room adjacent to the existing Reh abilitation Annex Building (in co-ordination with the Officer-in-charg e)so as not to affect the safety and stability of the building or its ma in structural elements.

- Ø Construction of lift shaft, lift lobby and lift room as necessary for the lift so as to provide ease of access to the users into the lift from the Rehabilitation Annex Building.
- Ø Installation of the lift including all necessary electrical connections a nd provision of safety measures.
- Ø Any Minor modifications required for the non-structural elements of the Rehabilitation Annex Building for the Installation of the lift are t o be done after taking approval of the Officer-in-charge and the sa me shall be rectified and finished appropriately after completion of the installation.
- 4. The lobby and passage to the lift should allow movement of wheelc hair and stretcher.
- 5. Bidder must submit detailed specifications including sizes and mate rials of construction along with drawings for their proposed lift shaft I ift lobby and lift room, as required for installation of the lift.
- 6. Minimum three years of warranty shall be assured by the sel ected vender. After that 05 years CMC will be taken by the su ccessful bidder.
- 7. CMC for equipment is required for a minimum of 5 years after warr anty period. CMC amount quoted along with equipment value will be paid after satisfactory completion of CMC on a yearly basis.

After installation, an agreement will be made by bidder for CM C. L1 eligible bidder will be given order for supply and installat ion of equipment at SVNIRTAR and he will also be given CMC a s per quoted rate after agreement.

Payment of CMC will be made on yearly basis after satisfactoril y completion and submission of manual bill duly certifying from the user wing. For CMC, a minimum of two visit of party is mandatory in each quarter and further on calling as and when required or breakage of equipment. All required spare parts & consumables will be provided by the CMC party. Authority may change or add the T&C and can cancel the CMC if required.

Security amount will be deposited as per contact order amoun t till completion of CMC.

8. Bidders must participated in the without CMC and with C MC bid of 15 passengers lift. Though it is individual evaluation bid, but bidder must be participated and fill the price bid of schedule 1 & 2. Participation in only one schedule will not be accepted. Schedule 3 to 5 is optional and may not be participated. But bid will be accepted schedule wise considering the estimate amount.

C. Standard Terms and conditions

- a. The Service Provider must quote by considering the location(s) and o ther accessories necessary for successful completion of the supply, in stallation and services under the scope of work.
- b. The Service Provider is advised to see the site conditions and nature of job and acquaint them with the site condition before submission of bid. No claim on this account shall be entertained at a later date.
- c. All tools, tackles, machines, plants and all other equipment's relevan t to the work shall be arranged by the bidder and cost with respect to the same shall be borne by bidder alone.
- d. The Laborers/Supervisor shall be arranged by the bidder at his cost f or the work.
- e. The bidder has to transport his material/accessories, equipment's an d other tools etc. on his own cost.
