**SETTING UP OF EARLY INTERVENTION CENTRE-CUM-
PREPARATORY SCHOOL**

SVNIRTAR is running an Early Identification Intervention Clinic since 3rd April, 2017 after approval of 94th EC held on 4th January 2017. One post of Physiotherapist and Occupational Therapist each has been engaged.

Presently, the clinic is running at 400sqft. room which is inadequate and non-conductive to run a clinic as per the ministry's guidelines. So, in the 106th EC which was held on 13.12.2019 it was approved to start a fullfledged Early Identification Intervention Clinic and Preparatory School, in a 5000sqft area with further requirements of manpower and equipments.

However, the new building where the area of 5000 sqft has been earmarked for the EIC to establish, is yet to be handed over by CPWD to SVNIRTAR. As per the Ministry's letter No. 16-02/2019-DD-III dated 18.08.2020, SVNIRTAR needs to start the EIC in the existing Rehabilitation Building with another three rooms adjacent to the present operated EIC room is proposed to operationalize by the prescribed time limit i.e. within two months)

Considering the urgency of the matter followed by the instruction from the Ministry, approval for budgetary provision of the following works need to be undertaken in modifying and renovating the four rooms for opening of EIC are as follows:

1. Homogeneous Vinyl Flooring works approximate budget - Rs. 1 Lakh (1350sqft)
2. Vinyl with paper back wall paper plain/Textured (3500sqft)- Rs.2.1Lakh
3. Room partition work for different section and screens - Rs.0.5Lakh
4. Software of General Services for EIC & }
Server Hosting charges AMC } - Rs.0.75Lakh

Total - Rs.4.35Lakh

The above said proposal was sent to Ministry vide letter No. DR 1A 57 dated 21.09.2020 seeking approval on estimated budget/expenditure of Rs.4.35 lakh and subsequently the Ministry has directed vide letter no. N-1304/2/2020-NI dated 30 September, 2020 (Copy attached) that the proposal may be placed before the EC for approval through circulation.

The Executive Council is requested to approve the above proposal.
