# Item No.122.3: To consider the proposal for optimizing infrastructure at NIs/ CRCs:

**Decision:** EC discussed and approved the proposal for optimizing Infrastructure at NIs / CRCs with certain advices.

- All OPD charges i.e. Registration / Diagnostics / Treatment Fee to be waived off for UDID card holders, as well as for those who have disability certificate and have got enrolled on UDID portal, irrespective of % of disability, w.e.f. 1<sup>st</sup> January 2023 as proposed.
- IPD charges i.e. Registration / Diagnostics / Diet / Treatment Fee to be waived off for UDID card holders, as well as for those who have disability certificate and have got enrolled on UDID portal, irrespective of % of disability, w.e.f. 01<sup>st</sup> January 2023 only for General Bed patients and not for patients admitted in Cabins.
- OPD services on Saturdays from 08.30 am to 01.00 pm to be provided with deploying staff through roaster duty from 01<sup>st</sup> January 2023.

# ItemNo.122.4: Post facto approval for engagement of Contractual personnel at SVNIRTAR and its CRCSREs:
