**Item No.120.1: Budget for Inauguration of 100 Bedded Annex Building at SVNIRTAR, Cuttack:**

After detailed discussion, the Executive Council approved the Proposed Budget of **Rs.35.35 lakh** for Inauguration of 100 Bedded Annex Building at SVNIRTAR, Cuttack subject to the following terms and conditions:

- i. As compared to the originally proposed rates of 10,000/- and 5,000/-, EC approved the rates of mementos upto (not for) 5,000/- and 3,000/- respectively.
- ii. Separate Tender shall be floated for -
  - a. Rs.19.10 lakh for Stage with Ramp (including Tent, Sound System, Tables, Chairs, Photography, Videography and You Tube live Streaming etc.).
  - b. Rs.1.58 lakh for Banners and Printing of Standees etc.
  - c. Rs.1.68 lakh for lunch for Hon'ble Ministers and VVIPs including their PA/PS, Senior Officials of Police, Media and District Administration.
  - d. Rs.2.43 lakh for lunch of Staff, Students, PwDs including their Attendants, Police and other Workers.
