Item No.40.2: Action Taken Report (Follow-up Action):

The General Council noted the Action Taken against the 39th General Council held on 28th February 2022 with the following observations:

- i. Proposal for resolving network issues for joining and attending meeting on video conferencing: The proposal was placed before 117th Executive Council meeting held on 23rd May 2022.
