### **EXPRESSSION OF INTEREST (EOI)**

Swami Vivekanand National Institute of Rehabilitation Training and Research (SVNIRTAR), Olatpur, Cuttack an Autonomous Body functioning under the administrative control of Department of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Government of India invites applications from interested Individuals /Trusts/Societies/NGOs & Charitable Organizations in two parts (Technical and Financial) to establish "Pradhan Mantri Bhartiya Janaushadhi Kendra" inside SVNIRTAR Campus. The interested applicants are required to submit their offer in the prescribed format of this EOI.

#### **GENERAL TERMS AND CONDITIONS**

- It will be incumbent upon each applicant to fully acquaint themselves with the local conditions and factors at the respective location/site which would have any effect on the performance of the contract.
- The applicant is expected to obtain for themselves on their own cost and responsibility all information that may be necessary for preparing the bid and entering into the contract.
- Two rooms measuring 260 sqft. with an outside counter and accessibility features, connected with water and electricity facilities shall be provided by the Institute.
- d) The PMBJK operator shall have to bear the Electricity Bill and maintain the allotted space properly.
- The PMBJK operator shall arrange the required furniture, fixture and equipments required for the e) PMBJK at their own cost.
- f) The PMBJK operator is responsible for obtaining drug license in the name of Pradhan Mantri Bhartiya Janaushadhi Kendra and other permissions to run a drug store. Compliance to all statutory requirements for storage of drugs shall be ensured by the operator.
- The PMBJK operator has to strictly keep the Janaushadhi Kendra open during the working hours of the Institute and the Janaushadhi Kendra will not be closed except on public holidays.
- It will be mandatory to keep generic Medicines in the Janaushadhi Kendra. h)
- i) PMBJK operators will be allowed to sell allied medical products, commonly sold in chemist shops but are not supplied by PMBI.
- The PMBJK operator shall at their own cost maintain and keep the offered premises in good and j) hygienic condition and will keep it neat and clean and functional at all times.
- The PMBJK operator shall at its own cost appoint their own adequate staff to run the said shop. Such staff appointed by the operator shall not be treated as a staff of SVNIRTAR and shall not have any claim or lien on SVNIRTAR for any dues.
- The PMBJK operator will not use the store/shop for sale of other than Generic Medicines or any unauthorized or illegal or extraneous/obnoxious/banned drugs which are spurious, soiled, damaged, post-dated or expired or adopt any unfair means to boost the sale.
- m) The operation of the Janaushadhi Kendra, SVNIRTAR will be done in the letter and script as per the terms & conditions, guidelines for the operation of Pradhan Mantri Bharatiya Janaushadhi Kendra.
- Janaushadhi Kendra's complete accounts and stock will be maintained through computerized system. All billings should be done using PMBI's software. No medicine can be sold in PMBJK without using PMBI's software.
- The PNBJK operator shall not assign, transfer, sub-let, pledge the operation of the Jan Aushadhi Kendra at any time during the tenure of the contract.
- In case of any information/document furnished by the applicant is found to be false and submitted with an intention to deceive at any stage, it would be deemed to be breach of terms and conditions of the EOI and may result in legal action beside termination of the agreement.

#### 2. AGREEMENT PERIOD

Initially the agreement of lease will be executed for a period of three years from the date of signing of the agreement of lease which shall be renewed every year as desired by the authority. The Competent Authority will assess the performance of the agency before completion of tenure of three years. After reviewing, if the performance of the agency is found to be satisfactory, then the agreement of lease may be considered for renewal for another term of one year.

#### 3. EARNEST MONEY DEPOSIT AND SECURITY DEPOSIT

- a) The applicant shall be required to furnish Earnest Money Deposit (EMD) for a sum of ₹25,000/(Rupees Twenty-Five Thousand) only along with the EOI document by way of Demand Draft/Bank
  Guarantee obtained from any Nationalized/Scheduled Bank and drawn in favor of "The Director,
  Swami Vivekanand National Institute of Rehabilitation Training and Research" payable at
  Cuttack.
- b) Submission of Tender Document without the EMD will be considered as non-responsive and will be summarily rejected.
- c) The EMD shall be refunded to the un-successful applicants after publication of the result of the successful applicant. No interest shall be paid on such EMD.
- d) The successful applicant who shall be awarded the contract shall deposit a sum ₹50,000/- (Rupees Fifty Thousand) only as Security Deposit in the form of Demand Draft/Bank Guarantee in favour of "The Director, Swami Vivekanand National Institute of Rehabilitation Training and Research" payable at Cuttack.
- e) In case the operator fails to enter into agreement or execute the job after entering into the agreement, then Institute shall have the right to forfeit the Earnest Money Deposit/Security Deposit as the case may be.

#### SELECTION CRITERIA 5.

Financial Bids of technically qualified applicants will alone be considered for financial evaluation. Award of Contract will be made to the successful evaluated applicant whose bid has been found to be responsive, qualified the technical criteria and has quoted the highest rent in the Financial Bid. In case of tie in the Financial Bid, applicant who possess more years of experience in running PMBJK from amongst the highest quoted bidders shall be selected and awarded the contract.

Upon selection of the operator, lease agreement shall be entered into between Director, SVNIRTAR and the operator.

#### 6. PAYMENT TERMS

The price quoted by the bidder, shall remain valid for the entire contract period. Payment shall be made at agreed rates except for Electricity, Water Charges, etc. which shall be charged as per actual consumption.
