# **GUIDELINES TO AUTHORS**

### International Conference on

Recent Advances in Early Intervention: A Disability Perspective

You are invited to submit your research contributions for presentation at the International Conference on *Recent Advances in Early Intervention: A Disability Perspective*. Submissions are welcome under the following categories:

#### 1. PAPER PRESENTATION

Papers should be based on original research, evidence-based practice, or innovative programs in the field of early intervention, rehabilitation, or relevant disability studies related to early intervention. The content should clearly present research objectives, methodology, findings, implications, and recommendations.

Each presentation will be allotted 10 minutes, followed by 2 minutes for questions and discussion. Authors are encouraged to focus on applied outcomes and translational impact within early intervention contexts.

#### 2. POSTER PRESENTATION

Posters should reflect completed or ongoing research, innovative practices, or case-based experiences related to early intervention and relevant disability services related to early intervention. The poster should clearly outline objectives, methodology, results, and conclusions. A 30-minute interactive session (including Q&A) will be allocated for poster presenters. Poster dimensions: Maximum 200 cm (height) × 90 cm (width).

Visuals should be clear, accessible, and inclusive, following universal design principles.

#### 3. ABSTRACT SUBMISSION GUIDELINES

Title length: Maximum 20 words (English).

Abstract length: Maximum 250 words (English).

Abstracts should include background, objective, methods, key findings, and

implications.

**Keywords:** Up to 5 relevant keywords.

Abstracts must be submitted in Microsoft Word (.doc/.docx) format.

Once submitted, abstracts cannot be modified.



#### 4. FULL PAPER SUBMISSION GUIDELINES

Papers should follow APA formatting.

File format: Microsoft Word (.doc/.docx).

**Paper size:** 8.5 × 11 inches, **Font:** Times New Roman, **Size:** 12 pt, **Spacing:** single, **Margins:** 1 inch on all sides,

Text alignment: justified.

Word limit: Up to 5000 words, including references.
