1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

Scope of Work:

1. Carrying out site survey, inspection of the two hospital buildings (Rehabilitation Services Building and Rehabilitation Annexe Building (with total floor area of 11,450 sqm, approximately), perip

heral area and other aspects as per requirement of Town Planning Authority and for getting Fire Safety Certificate. Site inspection report to be submitted with signature by the Architect as per their requirement.

2. Preparation of Drawings of the two buildings including site plan, layout plan, floor plan, four side elevations, drainage & sewerage disposal drawings etc., area statements showing plot area, built-up area, FAR area, parking area, plantation area, approach roads, solar system & rain water harvesting etc.
3. Preparation of key plans/ layout plans showing set-backs of existing buildings, proposed buildings, parking, plantation and approach roads etc.
4. Biomedical treatment plants to be shown in the Key plans.
5. The drawings are to be signed by Architect, as required by the Town Planning Authority and for getting Fire Safety Certificate.
6. Coordination with Town Planning Authority & Directorate General of Fire Service, Home Guards & Civil Defence, Odisha for understanding their requirement and multiple revisions in the above drawings, as per their requirement, till acceptance of the same by them.
7. Signed drawings are to be submitted in multiple copies in A1 and A0 sizes, as per requirement.
8. The softcopies of the drawings are also to be submitted (in layered DWG & PDF formats) along with scanned signed drawings in PDF format.

Terms & Conditions:

1. Architectural firms having previous experience of preparation of such drawings may submit their quotation for the above work.
2. The bidding firm or its Architect(s) must be registered with the Council of Architecture (COA) under the Architects Act, 1972. Submit certificate.
3. The bidder must submit valid GST Registration and Income Tax Returns (ITR) for the last financial year.
4. Site survey and preparation of drawings are to be completed within 30 days from the date of award of work.
5. Subsequent revisions to be carried out as and when necessary.
6. It is the responsibility of the selected Architectural firm to coordinate

dinate with appropriate authorities and understand their requirements and prepare/ revise the drawings.

7. As the buildings have been constructed by CPWD, the selected Architectural firm may contact CPWD as well to obtain related information, if required. SVNIRTAR will provide copies of preliminary layout drawings prepared by CPWD, for reference.
8. 40% of contract value shall be released upon completion of survey work and submission of drawings as per requirement.
9. Subsequent instalments of payment are subject to progress of coordination with appropriate authorities, revision of drawings as per their requirement and their acceptance of the same.
10. The entire assignment has to be completed within a time span of 90 days from the date of award of work.

Standard Terms and conditions

- a. **The Service Provider must quote by considering the location(s) and other accessories necessary for successful completion of the work under the scope of work.**
- b. **The Service Provider is advised to see the site conditions and nature of job and acquaint themselves with the site condition before submission of bid.**
- c. All tools, tackles, machines and all other equipment's relevant to the work shall be arranged by the bidder and cost with respect to the same shall be borne by bidder alone.
- d. The Labourers/Supervisor shall be arranged by the bidder at his cost for the work.
- e. The bidder has to transport his material/accessories, equipment's and other tools etc. on his own cost.
- f. Bidder shall follow the safety rules of the buyer's organization.
- g. Bidder's personnel while working at the location shall follow all the safety precautions to prevent any accident. The bidder shall be fully responsible for any mishaps, loss, damages caused by his men during the working either to his men or to buyer's property. The buyer reserves all the rights for recovery of appropriate amounts from his bill/security deposit to compensate such losses.
- h. No residential accommodation can be provided to the firm or his team of workers during execution of work.

- i. The service provider is responsible for due compliance of laws/norms relating to safety during execution of work. The entire risk and responsibility pertaining to this contract regarding the safety & security of men, materials & machine shall rest on the service provider.
- j. In case of breach of any laws, acts, rules mentioned above or any terms of contract mentioned herein, the contract shall be cancelled automatically.
- k. The service provider shall execute the contract through own work force. Sub-contracting will not be allowed.
- l. Work will be executed as per instructions of Engineer-in-charge.
- m. Engineer-in-charge shall have the right to stop the execution of work at any stage or time, if the quality of work is found inferior, if the progress of work slower or if the work is not executed as per specifications/instructions of Engineer-in-charge.
- n. The service provider shall not cause any damage to the work, nor shall hinder other contractors works. The cost of any damage done by the service provider to the existing infrastructure of the Institute or other contractors works, shall be borne by the defaulter with additional penalty as decided by the Director, SVNIRTAR.
- o. Execution work and installation of fittings etc. (as per work order) is the entire responsibility of the contractor.
- p. In case the service provider commits any breach of contract, the institute may at any time by notice in written summarily terminate the contract without compensation to the service provider for any reason.
- q. Bidder must be the local area within 50 kms from the Institute for providing better service as and when required.
- r. The bidder should not have been blacklisted by any organization.
