The State Election Commission, Uttarakhand, a constitutional body, invites applications from eligible and experienced advocates for empanelment as an **Advocate-on-Record (AOR)** to represent the Commission before the Hon'ble Supreme Court of India.

1. Eligibility Criteria

Applicants must meet the following minimum qualifications:

• Must be a registered Advocate-on-Record with the Supreme Court of India.

• Minimum 10 years of experience after registration as an AOR, with proven experience in handling matters of Public Law (including Constitutional, Administrative, and Election Law).

## 2. Terms of Engagement & Remuneration

• **Duration:** The initial empanelment will be for a period of **three (3) years**, subject to a satisfactory annual performance review.

• Remuneration: The fee and allowances payable shall be governed by the rates prescribed in the relevant and currently applicable Government Orders/Notifications issued by the Government of Uttarakhand. Details are provided in Annexure-C.

• Payment Terms: The Commission shall endeavor to process all valid invoices within 90 days of submission.

• Confidentiality: The advocate shall maintain the utmost confidentiality of all information shared by the Commission.

• **Termination:** The Commission may terminate the empanelment with a one-month notice for non-performance or breach of contract. An advocate whose empanelment is terminated for non-performance shall not be eligible to apply in the next empanelment cycle.

• Conflict of Interest: The empanelled advocate shall not advise or represent any party with an interest adverse to the Commission. Further, the advocate shall not advise or appear against the Election Commission of India or any State Election Commission during their tenure.

• Engagement for Supreme Court Matters: The AOR will be primarily responsible for filing all petitions/applications and managing all procedural formalities. The AOR shall be required to be present during all hearings and may also be required to argue cases as deemed fit by the Commission. Even in cases where a separate Arguing Counsel is engaged, the AOR's presence and assistance during the hearing are mandatory. The assignment of roles shall be at the sole discretion of the Commission.

#### 3. Application Procedure

- Interested advocates can download Annexure-A (Application Form), Annexure-B (Declaration Form), and Annexure-C (Schedule of Fees) from the Commission's website at www.sec.uk.gov.in.
- The application form, duly filled, must be accompanied by the signed declaration form and the following self-attested documents:
  - o Detailed Curriculum Vitae (CV).
  - o Copy of Bar Council Registration Certificate.
  - o Copy of AOR Registration Certificate.
  - A list of significant reported/unreported judgments to serve as proof of experience.

• The complete application set, with all documents scanned and compiled into a single PDF file, should be sent by email to sec-uttarakhand@uk.gov.in. The subject line of the email should be "Application for Empanelment of Advocate-on-Record for Supreme Court".

• The last date for receipt of applications is 15th October 2025.

#### 4. Selection Procedure

Applications will be scrutinized by a committee constituted by the State Election Commissioner. The Commission may, at its discretion, call applicants for an interaction/interview. The decision of the Commission regarding selection and empanelment shall be final and binding.

Note on Drafting & Filing Fee: The specified fee of ₹ 15,000 is an all-inclusive fee for both drafting and filing the primary substantial pleading in a case (e.g., Special Leave Petition, Writ Petition, main Counter-Affidavit). It is expressly clarified that this single, all-inclusive fee also covers the drafting and filing of all ancillary documents (such as miscellaneous applications, rejoinders, caveats, etc.). No separate or additional charges shall be payable for either drafting or filing any subsequent documents in the same case.

**Note on Connected Cases:** For connected cases, the fee for additional cases is capped at a maximum of  $\ref{total}$  15,000. Therefore, the total maximum drafting and filing fee admissible for a batch of connected cases (including the first case) shall not exceed  $\ref{total}$  30,000.
