If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 2. 4. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021\\_PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

9. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. **1. Generic**

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing- the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. **Generic**

## 21. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. ## 22. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 15 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). 7. **Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the SELLER):** Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. **Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Seller.** For in-house testing, the Sellers will provide necessary facilities free of cost. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per

er GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or Nominated External Inspection Agency prior to the goods' shipment. When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.

#### 8. Additional Specification Parameters - Ball Point Pens as Per IS 3705 (287500 pieces)

(a) Vocab - D003, Desk Type Ball Point Pen NGO Basic Specifications : The material used in manufacturing of Ball Point Pen shall be plastic. The plastic used shall be either polypropylene or type - 3 polystyrene conforming to the BIS Spcn. No. IS:2267 - 1972 as amended up to date. It shall also satisfy the accelerated ageing test as specified in column no. 7.1 and flammability test specified in column no. 7.2 of BIS specification no. IS: 3705 - 1980 as amended up to date. The Pen shall be free from any objectionable smell.

(b) Workmanship : The pen shall be of two parts. The upper part (cap) of the pen made of blue coloured plastic of length  $3.6 \pm 0.2$  cms. having a pocket clip of length  $4.0 \pm 0.2$  cms. The tip of the clip shall be rounded smoothly and evenly so that it does not tear the cloth when clipped in & out and shall have a reasonably tight grip. The pressure of the clip shall be such that when a pair of paper is inserted the clip holds it firmly but does not tear it. The lower part of the pen shall be translucent white and made of plastic with two consecutive blue line on it. The overall length of the pen shall be 14.2 cms.  $\pm 2$  mm. The length of the lower part of the pen shall be 13.2 cms.  $\pm 2$  mm. including the tip of the refill. The projection of the tip of the refill protruding outside the pen shall be  $3.5 \pm 1$  mm. The pen shall be uniformly tapered at the writing end. The diameter of the lower part shall be  $7 \pm 1$  mm. The lower part of the pen shall contain one fixed refill. The refill of the Ball Point Pen shall meet the requirements of the BIS specification No. IS 3707: 1984 (Second revision May, 2010). The diameter of the ball of the writing tip shall be  $0.5 \pm 0.1$  mm. The writing tip shall be securely & tightly fitted on the tapered portion of the lower part so that the writing tip shall not move or rotate during writing. The colour of the refill shall be blue only. The refill shall retain its quality for at least 18 months from the date of supply of the stores.

(c) Packing : Each pen shall be first packed with cellophane paper. 10(ten) such pens shall then be packed in a strong box made of nicely coloured duplex/ pulp board box of substances not less than 250 GSM. 10(ten) such boxes shall then be packed in a strong bigger box made of good quality nicely coloured corrugated carton of GSM not less than 400. Each big box shall be suitably closed by pasting gum tape around it to prevent tampering.

(d) Marking : Government arrow mark, Supplier's Name, Year of Supply and the words "Government of India" shall be printed prominently on each pen at a suitable place. The contents, description of the item, name of the supplier, Govt. arrow mark, month and year of manufacture shall appear on each small box at a suitable place. In addition, the bigger boxes shall show the description of the item and contents in the box at suitable place so as to be easily read when packed. Each small box and bigger box shall be properly closed with a strong Cello Tape around it in a suitable manner.
