CONSTITUTION OF INDIA.

No. Matsya. 2008/CR-199/ADF-12.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, and in force in the state the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Assistant Commissioner of Fisheries (Administration)/ Assistant Commissioner of Fisheries (Loan and Recovery), in Maharashtra Fisheries Services, Group 'A' in the Maharashtra Fisheries Service in the Commissionerate of Fisheries under the Agriculture, Animal Husbundry, Dairy Development and Fisheries Department of Government of Maharashtra, namely:--

- These rules may be called the "Assistant Commissioner of Fisheries (Administration)/Assistant Commissioner of Fisheries (Loan and Recovery)", in Maharashtra Fisheries Services, 'Group 'A' ' (Recruitment) Rules, 2012.
 - 2. In these rules, unless the context requires otherwise,-
 - (a) "Commission" means the Maharashtra Public Service Commission.
 - (b) "Commissionerate" means the "Commissioner of Fisheries" under the "Agriculture, Animal Husbundry, Dairy Development and Fisheries Department" of Government of Maharashtra.
 - (c) "Department" means "the Agriculture, Animal Husbundry, Dairy Development and Fisheries Department."

- 3. Appointment to the post of "Assistant Commissioner of Fisheries (Administration)/Assistant Commissioner of Fisheries (Loan and Recovery)," in Maharashtra Fisheries Services, Group 'A' in the Commissionerate of Fisheries shall be made either:—
 - (a) by promotion of suitable person on the basis of seniority, subject to fitness from amongst the persons.
 - (i) holding the post of Maharashtra Service of Fisheries (Administration), Group-B (Gazetted) "Administrative Officer/Planning Officer/Budget Officer/Rcovery Officer" in the Commissionerate of Fisheries;
 - (ii) having Minimum three years regular service on that post.

OR

- (b) by transfer of a suitable person holding equivalent post from any Department of Government;
- 4. A person appointed to the post mentioned in rule 3 shall be required to pass examination in Hindi and Marathi Language according to the rules in that behalf, unless he has alrady passed, or has been exempted from passing these examinations.
- 5. A person appointed to the post mention in Rule 3 should pass a Certificate in Computer Operation prescribed by the Directorate of Information and Technology, Government of Maharashtra, from time to time.
