Subject: Guidelines for implementation of Aquaculture and Fisheries development activities of Dharti Aaba Janjatiya Gram Utkarsh Abhiyan of Ministry of Tribal Affairs under the Pradhan Mantri Matsya Yojana (PMMSY)

Sir/Madam,

I am directed to refer to the captioned subject and to inform that the Government has in September 2024 approved the Dharti Aaba Janjatiya Gram Utkarsh Abhiyan(DAJGUA) a scheme of Ministry of Tribal Affairs(MOTA) for its implementation during a period of 5 years from the financial year of 2024-25 to 2028-29 in the States/UTs. The DAJGUA envisages comprehensive development of tribal areas and communities by addressing critical gaps in infrastructure, healthcare, education, and livelihoods, through a coordinated approach and convergence of various schemes of Government of India including the Pradhan Mantri Matsya Yojana (PMMSY) of Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India. The DAJGUA aims to improve the socioeconomic conditions of tribal communities by adopting saturation coverage for tribal families in tribal-majority villages and Aspirational Blocks. The interventions envisaged under DAJGUA will be prioritized for Scheduled Tribe(ST) beneficiaries in tribal villages of Aspirational blocks and the pockets of high tribal concentration and low development i.e. tribal-majority villages with at least 500 population and 50% or more STs and a total of 63,642 villages across India have been identified for implementation of the DAJGUA.

- 2. State-wise details of the Districts/ Block/Villages and Tribal population identified for implementation of the fisheries and aquaculture related activities of Dharti Aaba Janjatiya Gram Utkarsh Abhiyan under the Pradhan Mantri Matsya Yojana (as received from the Ministry of Tribal Affairs) are furnished at Annexure-I.
- 3. The interventions envisaged for the Department of Fisheries, GoI under the DAJGUA are to promote economic empowerment of tribal fishermen and CFR holders through aquaculture support under the Pradhan Mantri Matsya Sampada Yojana(PMMSY). Under DAJGUA, it has been targeted to cover 10,000 communities and 1,00,000 individual beneficiaries for fisheries and aquaculture support. DAJGUA provides that the existing norms of concerned schemes/grant of the respective Ministries will stand modified, wherever applicable, for achieving the objectives of this Abhiyan. However, such modifications in the scheme guidelines will apply only to the targeted beneficiaries/area to be covered under the DAJGUA and not to other beneficiaries/area being covered under relevant schemes of MoTA and the Ministries/Departments.

- 4. Accordingly, I am directed to convey the approval of competent in this Ministry and to forward herewith detail guidelines for implementation of aquaculture and fisheries development activities of the Dharti Aaba Janjatiya Gram Utkarsh Abhiyan of Ministry of Tribal Affairs under the Pradhan Mantri Matsya Yojana (PMMSY). The salient feature of the guidelines mainly include (i) extending governmental assistance up to 90% to Tribal beneficiaries for taking beneficiary oriented activities, (ii) community base activities are treated as non-beneficiaries oriented activities and 100% funding is provided by the Government (Central + State) it is shared as per the existing funding pattern of PMMSY. The funds requirements for implementation of the fisheries and aquaculture activities of the DAJGUA will be earmarked and met from the DAPST/TSP of PMMSY.
- 5. It is requested that the State Governments and Union Territories(UTs) (Annexure-I) are requested to sensitize all beneficiaries and other stakeholders regarding the provisions of the aforementioned scheme and forward the proposals for implementation of aquaculture and fisheries development activities of DAJGUA under the Pradhan Mantri Matsya Yojana (PMMSY) in accordance the enclosed guidelines.
- 6. This issues with the approval of Competent Authority in this Ministry vide Dy No j-01013/48/2024-Fy dated 10th January, 2025.

1. Introduction

- 1.1 India has a Scheduled Tribe (ST) population of 10.45 crore comprising 5.25 crore males and 5.20 crore females as per Census 2011. This group represents 8.6% of the total population and 11.3% of the total rural population. There are more than 705 tribal communities, spread across the country, living in remote and hard-to-reach areas.
- 1.2 Government of India has been implementing various programmes for development of tribal. Despite India's tremendous growth and overall development across socio-economic and human development indicators, the tribal population continue to lag behind in education, health, infrastructure and resultant socio-economic parameters.
- Janjatiya Gram Utkarsh Abhiyan (DAJGUA) with a total outlay of ₹79,156 crore for its implementation during a period of 5 years from the financial year 2024-25 to 2028-29 to focus on 25 interventions through 17-line Ministries. The DAJGUA envisions the comprehensive development of tribal areas and communities by addressing critical gaps in infrastructure, healthcare, education and livelihoods. Through a coordinated approach and convergence of various Government of India schemes including the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India, the mission aims to improve the socio-economic condition of tribal communities by adopting saturation coverage for tribal families in tribal-majority villages and Aspirational Blocks.
- 1.4 The Department of Fisheries, Government of India over the past ten years has spearheaded the transformation of the fisheries sector through various schemes and initiatives such as Blue Revolution, Pradhan Mantri Matsya Sampada Yojana(PMMSY), Fisheries and Aquaculture Infrastructure

Development Fund(FIDF), Pradhan Mantri Matsya Kisan Samridhi Sah-Yojana(PM-MKSSY) etc, with highest ever investment of Rs 38,572 crore since 2015.

The Department of Fisheries, Government of India is also participating in implementation of the DAJGUA. In this regard, various activities related to fisheries and aquaculture under PMMSSY will be implemented amongst the tribal fishermen and Community Forest Resource (CFR) holders for promotion of aquaculture under the Abhiyan. From PMMSY, it has been envisaged to support 10,000 communities and 1,00,000 individual beneficiaries under DAJGUA.

2. Pradhan Mantri Matsya Sampada Yojana (PMMSY)

- 2.1 Recognizing the importance of fisheries in the national economy and for focused and holistic development of the fisheries and aquaculture sector with socio-economic wellbeing of fishers, fish farmers and fish workers, Government of India in May 2020 as a part of Atmanirbhar Bharat package approved the Pradhan Mantri Matsya Sampada Yojana (PMMSY) at an investment of ₹20,050 crore. The interventions under this scheme aimed at enhancing fish production, productivity, modernization and strengthening of the value chain, creation of fisheries infrastructure, post-harvest management, robust fisheries management, regulatory framework and welfare of fishers and fishermen. The scheme also emphasises on addressing the critical gaps in infusion of technology, improving quality and hygiene in fish and fish products, value addition, marketing, promotion and enhancing stakeholders' economic returns.
- 2.2 PMMSY has been approved at a total estimated investment of ₹ 20,050 crore comprising of Central share of ₹ 9407 crore, State share of ₹ 4880 crore and Beneficiaries contribution of ₹ 5763 crore. PMMSY is being implemented in all the States and Union Territories for a period of 5(five) years from FY 2020-21 to FY 2024-25.

- 2.3 The PMMSY is an umbrella scheme with two separate Components namely (a)Central Sector Scheme (CS) and (b) Centrally Sponsored Scheme (CSS). The Centrally Sponsored Scheme (CSS) Component is further segregated into non-beneficiary oriented, and beneficiary orientated subcomponents/activities under the following three broad heads:
 - (i) Enhancement of Production and Productivity
 - (ii) Infrastructure and Post-harvest Management
 - (iii) Fisheries Management and Regulatory Framework
- 2.4 Under the PMMSY *inter-alia* envisages inclusive development and higher government financial assistance is provided to the beneficiaries of Schedule Caste(SC), Schedule Tribe (ST) and also women. The Scheme offers enhanced government financial assistance of 60% of the unit /project cost to ST beneficiaries compared to 40% for general category. PMMSY has been implemented with plethora of activities and many of such activities are suited for the tribal beneficiaries. Further, a minimum allocation of 8.6% of the annual outlay is earmarked for the Tribal Sub-Plan (TSP), ensuring targeted support for tribal development within the fisheries sector.
- 2.5 Under PMMSY, during the last for years (2023-24) and current financial year (2024-25) projects worth ₹ 1,614.52 crore with a central share of ₹ 743.45 crore for the Schedule Tribe beneficiaries have been sanctioned. The scheme has reached to 74,468 ST beneficiaries across the country so far, significantly improving their economic opportunities and livelihoods. The allocation for TSP under PMMSY during the last four years(2020-21 to 2023-24) and current financial year (2024-25) is ₹ 651.89 crore, which constitutes 9.68% of the total size of the budget allocated for implementation of the PMMSY during the above said period. Out of this allocation, ₹472.39 crore (72.46%) has been utilized during the said period, reflecting the commitment towards enhancing the socio-economic status of tribal communities in fisheries and aquaculture sector.

- 2.6 The Government has approved the DAJGUA with a total outlay of ₹79,156 crore, which aims to improve the socio-economic condition of tribal communities by adopting saturation coverage for tribal families in tribal-majority villages and Aspirational Districts. This will cover about 63,000 villages benefiting more than 5 crore tribal people.
- 2.7 In this reference, PMMSY envisions allocation of ₹375 crore from the Tribal Sub-Plan (TSP) funds of PMMSY to support tribal fishermen and Community Forest Resource(CFR) holders for promotion of aquaculture under the DAJGUA from the financial year of 2024-25 to 2028-29. PMMSY envisions to achieve the target set under DAJGUA within stipulated time to improve the socio-economic condition of tribal communities in tribal majority villages and Aspirational Blocks.

3. Area of Operations

- 3.1. The Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DAJGUA) will be implemented in all the States/UTs for the targeted beneficiaries.
- 3.2. DAJGUA prioritizes tribal villages of Aspirational blocks and the pockets of high tribal concentration & low development i.e. tribal-majority villages with at least 500 population and 50% or more STs (as per census 2011) (about 63,642 villages) across India.
- 3.3. State-wise indicative summary of Districts/ Block/ Villages and Tribal population as per the Ministry of Tribal Affairs(MoTA) where the DAJGUA is proposed to implemented are furnished at Annexure-I.

Aims and Objective

(i) Enhance socio-economic conditions of tribal fisherman and Community Forest Resource(CFR) holders in tribal-majority villages and aspirational blocks through fisheries and aquaculture activities.

- (ii) Empower tribal communities, and provide opportunities for alternative livelihoods in fisheries and aquaculture.
- (iii) To enhance the skill of tribal communities for taking up fisheries and aquaculture activities for their economic prosperity.
- (iv) Promote best practices, technological interventions in fisheries and aquaculture in Tribal area.

5. Eligible Beneficiaries

The eligible beneficiaries under DAJGUA includes the following:

- (i) Community Forest Resource (CFR) Holders of Tribal
- (ii) Tribal Fishermen/population living in tribal-majority villages
- (iii) Tribal Fishermen/population living tribal villages of Aspirational blocks
- 6. Nodal Implementing Agency(NIA)
- 6.1. The Department of Fisheries, Government of India will be the nodal Department in the Gol for the implementation, overall coordination, monitoring and evaluation of the fisheries development activities under DAJGUA in the tribal majority villages and aspirational blocks. DoF, Gol wherever felt necessary will assign the aforementioned task to any entity of Central and State/UT Governments or field institutions.
- 6.2. The extensive synergy and coordination shall be established between MoTA and DoF, GoI for implementation, monitoring, evaluation and reporting of fisheries and aquaculture related activities as per the needs of the DAJGUA.
- 7. End Implementing Agencies (EIA)

- 7.1 The selected component of PMMSY under DAJGUA would be implemented through the following agencies:
 - (i) Central Government and its entities including NFDB
 - (ii) State/UT Governments and their entities
 - (iv) Any other End Implementing Agencies as decided by DoF,GoI

8. Source of Funds

- 8.1. The Department of Fisheries(DoF), GoI shall allocate an amount of Rs. 375 crore under the Tribal Sub-Plan (TSP) of PMMSY to support tribal population and CFR holders for development of fisheries and aquaculture under the DAJGUA.
- 8.2. The Department of Fisheries, GoI being the nodal Department in the Central Government for implementation of the scheme shall earmark Budget for each year for implementation of the fisheries and aquaculture activities under DAJGUA as per the year-wise financial targets approved by the Cabinet and commencing from the year 2024-25 out of the budget allocated under Tribal Sub Plan (TSP). Similarly, the State Government shall also locate the matching grants under the state plan for TSP activities.
- 8.3. The fund for each year for implementation of fisheries and aquaculture @₹75 crore/year(Average) for 5 years from year 2024-2025 to 2028-2029 shall be earmarked under TSP Head from the Budget provided under the PMMSY.

9. Funding Pattern

9.1. Beneficiary orientated Activities

9.1.1. For the Beneficiary orientated i.e. individual/group activities subcomponents/activities to be implemented through the States/UTs, the Government financial assistance of both Centre and State/UT Governments together will be limited to 90% of the project/unit cost for tribal population

/CRF holders. The Government financial assistance will in turn be shared between Centre and concerned State Governments/UTs in the following ratio:

- The North Eastern & Himalayan States: 90% Central share and (a)
- Other States: 60% Central share and 40% State share.
- Union Territories (with legislature and without legislature): 100% (b) (c) Central share (No UT Share).
- Beneficiary contribution shall be upto 10% of the project/unit cost. The concerned State/UT Government may also supplement the beneficiary's 9.1.2. contribution, if desired to do so, to help to reduce the financial burden on the beneficiary.

9.2. Community Based Activities

- 9.2.1 For the community-based activities to be implemented though the State Governments, UTs, State and Central Governments entities, the entire project/unit cost (i.e. 100% Governmental financial support) will be shared between Centre and State as detailed below:
 - North Eastern & Himalayan States: 90% Central share and 10% State (a)
 - Other States: 60% Central share and 40% State share. (b)
 - Union Territories (with legislature and without legislature): 100% (c) Central share.

Activities Supported

10.1. Beneficiary oriented activities: DAJGUA envisages supporting 1,00,000 individual beneficiaries for development/promotion of aquaculture. The PMMSY has been implemented with plethora of 100 activities relating to fishers and aquaculture. The following activities of PMMSY relating to the fisheries and aquaculture including fisheries post-harvest have been segregated for implementation as beneficiary oriented activities under the DAJGUA: Harfur

- (m) Bivalve cultivation (mussels, clams, pearl, etc.)
- (n) Construction of Raceways of minimum of 50 cubic meter

- (s) Backyard Ornamental fish Rearing unit (both Marine and Fresh water)

- (ff) Fish Mills of production Capacity of 2 ton /Day
- (gg) Construction of fish kiosks including kiosks of aquarium/ornamental fish
- (hh) Providing boats (replacement) and nets for traditional fishermen
- (ii) Fish Value Add Enterprises Units

- 10.2. Community based activities: DAJGUA also envisages supporting 10,000 community and following community based activities for development of fisheries and aquaculture including post-harvest will be supported:
 - (i) Rejuvenation of community ponds
 - (ii) Common fish processing centre
 - (iii) Fish drying yards and facilities
 - (iv) Matsya Seva Kendras
 - (v) Stocking of Fingerlings in Reservoirs
 - (vi) Stocking of Fingerlings in Wetlands
 - (vii) Trainings, Awareness, Exposure and Capacity Building
 - (viii) Common cold storage, Ice-plants
 - (ix) Construction of Fish Retail Market
 - (x) Construction of fish retail markets including ornamental fish/aguarium markets.
 - (xi) Training, Awareness, Exposure and capacity Building
 - (xii) Outreach activities

11 Unit Cost and Financial Ceiling


- The ceiling of the government financial assistance many activities have been fixed based on the prevailing unit cost under the PMMSY. Beneficiary oriented sub-components and activities under the Centrally Sponsored Component of the PMMSY along with sub-components/activities-wise unit costs, Governmental assistance, terms and conditions are furnished at ANNEXURE-II and III.
- 11.2 Wherever, unit cost is not indicated both in beneficiary oriented and community based activities, such activities will be supported on project mode. The concerned State Governments/UTs and other implementing agencies will frame a detailed cost estimate of such activities based on the prevailing Schedule of Rates(SoR) and are also required to formulate a detailed Self Contained Proposal(SCP)/Detailed Project Report(DPR) in respect of such activities for availing the assistance under the PMMSY/ DAJGUA.

- 11.3 Given the remoteness and difficult terrain, differential unit costs for Islands, Himalayan States/UTs and the North-Eastern States would be permitted. For these States/UTs up to 20% markup would be allowed over and above the unit cost of the sub-components/activities indicated at ANNEXURE- II and III. However, it is pertinent to mention that while fixing unit costs for activities under sl-no 3 namely 'Development of Fisheries in North-Eastern and Himalayan States/UTs' in Annexure II, the factors like remoteness and difficult terrain have already been factored in. Therefore, the above-mentioned additional premium up to 20% will not be added to these unit costs indicated under sl-no 3 in Annexure II.
- 11.4 Any other location specific fisheries and aquaculture related activities.

12 Operational Modalities

- 12.1. The identification of tribal fisherman/CRF holders shall be done by respective State/UT Fisheries Department in consultation with field Institution and State Department of Tribal Affairs. The list of beneficiaries along with the proposal shall be submitted by the State/UT Fisheries Department to National Fisheries Development Board (NFDB) for consideration by the Projects Sanctioning Committee(PSC) in NFDB.
- 12.2. The approval of the proposals under DAJGUA shall be as per the existing approval process of Centrally Sponsored Scheme(CSS) Component of PMMSY. Flowchart of the approval process is given below:



13 Governance Structure

- The Governing structure of PMMSY at Central Government Level as 13.1 indicated below will govern the Implementation of the fisheries and aquaculture related actives of DAJGUA:
 - Central Apex Committee (CAC) (a)
 - Project Appraisal Committee (PAC) (b)
 - Project Monitoring and Evaluation Unit (PMEU) (c)
 - Project Monitoring Unit (PMU) (d)
- The institutional framework of PMMSY namely State Level Approval and 13.2 Monitoring Committee (SLAMC) at State/UT level will govern the implementation of and monitoring of the project activities of DAJGUA.

14 Administrative Expenses

PMMSY provides that 2.5% of the annual budgetary allocation under 14.1 PMMSY (central share) and the same would be earmarked for meeting the administrative expenses for implementation, monitoring, evaluation, and

review of the fisheries and aquaculture activities of DAJGUA by the DoF, NFDB and the End Implementing Agencies (EIAs).

- 14.2 The Department of Fisheries (DoF) will earmark the extent of funds under administrative expenses that would be utilised by DoF and also released to the NFDB & EIAs to meet the administrative expenses for implementation of the fisheries and aquaculture activities under DAJGUA.
- 14.3 Earmarked fund shall be reviewed periodically and may be increased by the DoF to meet the enhanced requirements of funds, if any, occurred on account of geographical, difficult terrain and unavoidable circumstance to ensure smooth implementation of the fisheries and aquaculture activities under the DAJGUA.

15 Outreach and Extension Plan

- Under DAJGUA, special focus will be accorded for Training and Capacity building of fishermen, fish farmers and fish workers and a comprehensive action plan will be prepared for this purpose.
- 15.2 Training and capacity-building programmes will educate and enable targeted beneficiaries for the grounding and successful implementation of their projects under the DAJGUA. These activities will facilitate active participation of potential beneficiaries, boost the uptake of PMMSY components, and extend outreach activities. Training and capacity building programmes will be designed to equip targeted beneficiaries with the skills and knowledge necessary to develop and implement the respective activities under PMMSY. Capacity building will also facilitate proper use of resources, reducing the risk of errors, misuse, or non-compliance with scheme guidelines.
- 15.3 Communication and awareness campaigns will leverage various media channels to reach out a broader base of target beneficiaries, raising awareness about the PMMSY activities. These campaigns will equip

participants with the necessary knowledge and documentation, encouraging adoption of recommended practices. Extension support will complement these efforts by providing hands-on assistance and expert advice, helping stakeholders effectively implement new techniques and technologies.

- 15.4 National Fisheries Development Board (NFDB) will function as national nodal agency for training, awareness, and capacity building including skill development/upgradation activities to be implemented under DAJGUA.

 NFDB will collaborate with various training partners including training institutions under Ministry of Tribal Affair to achieve the overall objectives of DAJGUA.
- NFDB shall be responsible and accountable for proper implementation of training or awareness or capacity building activities. NFDB will undertake coordination, monitoring and supervision of the programmes implemented through various institutions/agencies/organizations. NFDB will submit monthly report of Training and Capacity building progress to DoF, Gol

16 Monitoring and Evaluation

- 16.1 The monitoring and evaluation of the DAJGUA shall be monitored through established various committees under PMMSY. Ministry of Tribal Affairs shall undertake overall monitoring of the Fish culture support and promotion of aquaculture under PMMSY under the DAJGUA.
- The project proposals taken up under the DAJGUA will be monitored through a Project Monitoring Unit (PMU) headed by the Chief Executive, NFDB, Project Monitoring and Evaluation Unit (PMEU) headed by Joint Secretary, Department of Fisheries, a State Level Approval and Monitoring Committee(SLAMC) headed by the State Secretary in-charge of Fisheries and the District Level Committee headed by District Collectors/Deputy Commissioner of the District.

- 16.3 PMMSY existing Management Information System (MIS) will be used for regular monitoring of the physical and financial progress and deliverables under the PMMSY. As per the requirement, data from PMMSY MIS portal shall be shared to PM Gati Shakti Portal that maps tribal villages covered under the Abhiyan and monitors their physical and financial progress
 - The PMEU will review the progress periodically at least once in 6 (six) months and guide the implementing agency to ensure proper and speedy implementation of the projects. Besides, the Department of Fisheries may also depute its representatives regularly to the project site for physical inspection/verification.
 - No deviations in the approved project proposal will be permitted in the normal course. In case, the approved project proposal is to be revised with any addition/deletion/modification of approved items on account of Force Marjorie causes or any other unavoidable technical compulsions, such proposals will be placed before the SLAMC and PAC. The warranted midterm correctives arrived/recommended by the SLAMC and PAC will be placed before the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying for appropriate decision/consideration/approval.
 - The project implementing agency will submit a detailed progress report (both financial and physical) to the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying and NFDB on a monthly basis till the project is completed in all respect and a project completion report after the project is completed in all respects.
