Terms Condition:-

- 1) **Rate - Inclusive of all taxes (GST, IT) & Levies for each Drugs.** Rate should be valid for One Year from rate acceptance.
- 2) **Tablet & Capsules & oral powder formulations** (like sachets, bulk powders, or reconstitutable suspensions) **should be tested for**
 - Appearance-Visual quality, Weight Variation-Dose uniformity,
 - Hardness- Mechanical strength, Friability- Resistance to crumbling,
 - Disintegration-Breakdown in fluid, Dissolution- Drug release rate,
 - Moisture Content-Stability, Microbial Testing- Safety,
 - Content Uniformity- Correct API amount, Assay of API- Potency.
- 3) **For parenteral preparations (injections) both liquid & powder (for reconstitution) should be tested for**

- Sterility Test-Confirms absence of viable micro-organisms,
- Pyrogen/Bacterial Endotoxin Test-Ensures absence of fever-causing pyrogens,
- Particulate Matter Test-Detects visible and sub-visible particles,
- Clarity Test- Solution must be clear, free from turbidity or suspended matter,
- pH Determination- Confirms pH within specified range for stability and compatibility,
- Assay of Active Ingredient- Confirms potency,
- Uniformity of Content-Ensures each vial contains correct API amount,
- Reconstitution Time (Powder injections)-Powder should dissolve completely within specified time,
- Fill Volume/Weight Variation-Ensures correct volume/weight per unit,
- Stability Testing- Confirms product remains stable under storage conditions.
- **Note** -Sterility & endotoxin tests are absolutely mandatory for all parenterals. Powder injections add reconstitution time and content uniformity checks. Liquid injections require clarity and particulate matter testing. NABL labs must follow **ISO/IEC 17025** accreditation standards, ensuring validated methods and traceability.

4) For **External Applications** such as **Ointments, Creams, Lotions, Eye Ear Nasal Drops, should be tested for –**

- General Appearance-Check color, odor, homogeneity, absence of foreign matter,
- pH Determination-Ensures compatibility with skin/mucous membrane,
- Viscosity / Consistency- Confirms spreadability and uniform texture,
- Uniformity of Content-Ensures even distribution of active ingredient,
- Sterility Test- Confirms absence of microorganisms,
- Microbial Limit Test-Ensures absence of harmful pathogens (E. coli, Pseudomonas, Staphylococcus),
- Assay of Active Ingredient-Confirms potency,
- Particle Size/Homogeneity- Ensures smooth texture, no grittiness,
- Drop Size/Volume per Container- Ensures accurate dosing,
- Stability Testing-Confirms product remains stable under storage conditions.
- **Sterility is mandatory** for ophthalmic, nasal, and ear drops,
- **Viscosity and spreadability** are critical for ointments and lotions,
- **Microbial limits** apply to all non-sterile external product,
- **Assay and content uniformity** are universal requirements.


5) For **surgical dressings and related materials** like **absorbent cotton, gauze, bandage cloth, and rolled bandages, should be tested for –**

- Identification & Appearance-Must be white, odorless, free from stains, foreign matter & uniformly prepared,
- Absorbency Test- Measures time taken to sink in water and absorb fluid,
- Water Soluble Substances-Ensures removal of natural impurities (wax, fat, alkali, etc.),
- pH of Aqueous Extract-Confirms neutrality (no irritation to skin/wounds),

- Foreign Matter Test- Must be free from seeds, husk, dirt, or fibers other than cotton,
 - Loss on Drying (Moisture Content)- Prevents microbial growth and ensures stability,
 - Sulphated Ash (for Cotton)- Measures inorganic residue after ignition,
 - Sterility Test- No microbial growth,
 - Tensile Strength/Width & Length-Ensures mechanical strength and dimensional conformity as per BIS/IP specifications,
 - **Fluorescence Test (Cotton)**- Detects bleaching agents or optical brighteners & No fluorescence under UV light.
 - **Note - Absorbent cotton** has stricter chemical purity tests (water-soluble substances, sulphated ash, fluorescence).
 - **Gauze, bandage cloth, and rolled bandages** emphasize **mechanical strength, absorbency, and sterility.**
 - NABL-accredited labs in India follow **IP & BIS standards (IS 1640, IS 4736, IS 758)** for surgical dressings
- 6) After testing soft copy of report should be submit on email of this office immediately and hard copy should be submit through express courier (no charges will paid by this office) must reach within 2 days to this office.

Note: - There is no responsibility of this office, if any delay for submission of quotation due to post, courier, or anyway. **Quotation submitted through email is not acceptable.**
