1. Persons with disability (Divyang) candidates will be considered for admission on production of trade suitability certificate issued from the National Career Service Centre for Differently Able, at ITI Guwahati campus, Gopinath Nagar, Guwahati- 16, or **as per trades suitability**

communicated by DGT vide letter no. MSDE-19/02/2018-CD(pt) Dtd 2nd July,2019 and as mentioned in NCVT trades syllabee.

- 2. <u>VI category Dibyang candidates can apply for admission into Dibyang ITI Dibrugarh</u>
- 3. <u>Only TGL/Ex-TGL candidates can apply into Labour Welfare Industrial Trg. Center</u> <u>Rowriah(NCVT Private ITI).</u>

SELECTION PROCEDURE: Selection of candidates for admission will be made as per following procedure:

The candidate may choose the ITI as well as the courses from the course matrix table given in the website.

The seats will be allocated on merit, based on the basis of marks obtained by the candidate in the entry qualification examination & following reservation rules in force.

The Persons with Disability (Dibyang) candidates will be considered only on production of trade suitability certificate issued from the National Career Service Centre for Differently Able, at ITI Guwahati campus, Gopinath Nagar, Guwahati- 16, or **as per trades suitability communicated by DGT vide letter no. MSDE-19/02/2018-CD(pt) Dtd 2nd July,2019 and as mentioned in NCVT trades syllabee.**

The Economically Weaker Sections (EWSs) candidates will be considered on the basis of their Family Income Certificate as EWSs for the state of Assam, issued by the Competent Authority, & on production of the same, during the time of verification of their registration particulars at the Govt. ITI.

a. For Post Matric trades- In case of same percentage of marks obtained by the candidates in HSLC or equivalent examination with Science & Mathematics, the marks obtained in Mathematics will be considered, in case of similar marks in Mathematics, the marks obtained in English will be considered, at the time of preparation of merit list. If still the marks obtained by the Candidates are same, then seat will be allotted through randomization by the System.

b. Similarly for trades with **HSLC pass or equivalent qualification**, in case of similar percentage of marks obtained by the candidates, then the marks obtained in **Mathematics** will be considered, in case of similar marks in **Mathematics** then **English** marks will be considered, at the time of preparation of merit list. If still the marks obtained by the Candidates are same, then seat will be allotted through randomization by the System.

c.For Under Matric trades- in case of similar percentage of marks obtained by the candidates, in class VIII examination are same, the marks obtained in **Mathematics** will be considered, in case of similar marks in **Mathematics**, the marks obtained in **English** will be considered, at the time of preparation of merit list. If still the marks obtained by the Candidates are same, then seat will be allotted through randomization by the System.

d. If the seats in Under-Matric Trades remain vacant due to non-availability of 8th pass Candidates, then from 3rd e-Counseling onwards, those vacant seats will be opened for filling up by Post-Matric Candidates.

e. In case of Engineering and Non- Engineering Trades, the candidates must have passed the entry qualification examination with **Mathematics & English.**

f. In case of Non-Engineering Trades, in case of similar percentage of marks obtained by the candidates, then the marks obtained in **Mathematics** will be considered, in case of similar marks in **Mathematics** then **English** marks will be considered, at the time of preparation of merit list. If still the marks obtained by the Candidates are same, then seat will be allotted through randomization by the System.

g. In case of Bodo Language Transcription Trade(BLTT) the candidate must have English and Bodo language in qualifying examination, in case of similar percentage of marks obtained by the

candidates, then the marks obtained in **English** will be considered, If still the marks obtained by the Candidates are same, then seat will be allotted through randomization by the System.

h. If the candidate selects 8th class pass as entry qualification, he/she has to fill the marks of subjects of 8th class pass only for applying in the under matric trades having 8th pass entry qualification.

i. A copy of certificate which is to be obtained in format -I to be downloaded from the website & 8th pass mark sheet to be submitted during verification, with other original documents, if he/she has applied for the trades having 8th pass entry qualification.

j. If the candidate selects 10th pass as entry qualification, he has to fill the marks of subjects of 10th class (HSLC) pass for applying in Post matric trades &**if he/she also desires to apply for the trades having 8th class pass entry qualification** then he/she has also to fill the marks of subjects of 8th for applying in under matric trades.

k. A copy of certificate which is to be obtained in format – I to be downloaded from the website & 8^{th} pass mark sheet, to be submitted during verification, also for 10^{th} pass entry qualification along with HSLC mark sheet, with other original documents, if he has applied for both the trades having 8^{th} pass entry qualification & 10^{th} pass entry qualification trades.

I. The candidates of CBSE courses of CGPA pattern are to fill their marks of each subject by converting from CGPA (multiplying by 9.5 or as mentioned in the marksheet). No grade is allowed to put in marks table.

m. Candidates will be allowed only one time **upgradation up to** 5th **e-counselling**, based on their choice, if he/she does not opt to freeze his/her seat, at the time of admission.
