The SIO, NIC Himachal Pradesh welcomed Sh. IPS Sethi, State Coordinator, Himachal Pradesh who attended the meeting through desk top VC. The SIO informed about **activities undertaken** by NIC Himachal Pradesh during the month of March 2017. The SIO informed that basic agenda is the demo of Shreshth Himachal Mobile App. The Chief Secretary Himachal Pradesh will be holding VC with all the Deputy Commissioners of Himachal Pradesh. In the meanwhile, the Chief Secretary has desired that all the DIOs should be updated about the App and DIOs will inform about the functionality to all the Deputy Commissioners. He informed that the objective of App is that one will use Smartphone only to click the photo and will select the category of incidence; the App will automatically decide the authorities to inform on the basis of Geo Location of the photo.

Sh. Sethi, State Coordinator appreciated the good work being done by NIC HP. He raised few queries related to the App. He desired that the information may be sent to DG office after the launch so that the same app can be used in other states also. He informed that the DC/ DM Dashboard is being launched very soon and desired that a Pilot District could be taken up in the state of Himachal Pradesh. Data will be shared on the basis of APIs and depending on local

requirements customization will be taken up. He informed that for HP Public Service commission project, funds amounting to Rs. 5.2 Crore have been released. Modalities for the same will be worked out.

Sh. Sandeep Sood, PSA demonstrated the Shreshth Himachal Mobile App. It was decided that Directory of Government Officers as available in My Diary App will also be made part of Shreshth Himachal.

Sh. Sanjay Kumar, PSA, updated about the eHRMS Project and informed training requirements are being received on regular basis. It was decided that Sh. Sanjay Kumar will hold demonstration cum training for all DIOs within a week through VC.

Thereafter, **the DIOs informed about the actions taken** on the points discussed during the last monthly review meeting and the **activities undertaken** by them during the month.

- **eKalyan**: some of the DIOs shared feedback/ comments for the web based eKalyan Software. There was a request to provide option for reverting PLA Management. The SIO asked about payments through Post office Savings account, It was decided that Bank Master available under treasury project should be used in eKalyan.
- NDAL & ALIS: Most of the DIOs informed that the software is being tested and problems
 are being communicated to DIO Shimla. DIO Shimla informed that problem about UIN
 number generation was raised in Delhi meeting and it was assured that the problems will
 be taken care in the next version of the software. DIO Mandi raised the issue about the
 problems being raised by the manufacturers of arms.
- **eHimbhoomi:** It was agreed by all that in new tehsils, instead of old client server based software, new web based software should be implemented. For tehsils where there is no connectivity available, eHimbhoomi should be implemented in Offline Mode.
- Saarthi 4.0: SW has been implemented successfully and problems are being reported to Sh. Bhupinder Pathak, DIO Kangra who is getting these resolved. The DIO Kangra also informed that article on Saarthi is complete, he is only awaiting photographs. This is quite delayed now and will be considered in next issue. Vahan 4.0: Testing is in progress. Sh. Pathak also added that for new locations there is no issue but for old sites there are some issues in data porting, which are being resolved.
- Hot Dak Tracking System: DIO Shimla informed that servers have been prepared for implementation for Department of Ayurveda and Women and Child Development department training will be conducted soon
- Service Plus: It was informed that service for issuance of NOC by Department of Fire Services is being tested by the department. The SIO desired that the service should be launched on priority. Sh. Anurag Gupta, ADIO, Una informed that service for issuance of Disability Certificates has been completed and is being tested by the department.
- Lok PramanPatra: Many DIOs reported that the application runs smoothly only under Internet Explorer for other browsers it gives problem. Sh. Prithvi Raj Negi will look into the issue.
- **Circle Rates**: It was informed all the Districts except Kullu and Una have notified circle rates using Circle Rates application.
- **Digi Dhan Mela**: It was informed that all the DIOs are actively participating in the Digi dhan mela. Also most of the DIOs have conducted Trainings/ Workshops to spread awareness.
- Joining status of Treasury Manpower: The DIOs were requested to expedite the matter.
 The SIO was of the opinion that the manpower should be asked to prepare user manuals of various IFMS modules after training. The status will be reviewed in the next meeting.

Sh. Akshay Mehta, ADIO informed about Revenue related software, it was felt that the data for the same can be made available for DM Dashboard.
