The SIO, NIC Himachal Pradesh welcomed Sh. IPS Sethi, State Coordinator, Himachal Pradesh who attended the meeting through desk top VC. The SIO informed about **activities undertaken** by NIC Himachal Pradesh during the month of January 2017, especially, the Digital India Award –Gold 2016 for MDM Mobile App, Best Paper in the NCeG Compendium of papers and acceptance of other papers.

Sh. Sethi, State Coordinator appreciated the good work being done by NIC HP. He informed that the reviews have started and that the eligible officers must prepare well for the reviews. He wished all the officers, who are appearing for review his best wishes. The SIO thanked Sh. Sethi for his motivational guidance to all.

Sh. Sanjay Kumar, PSA, informed about the online transfers module implementation of eHRMS in the Elementary Education department. He added that additional modules have been created for wrongly entered data and module is being developed for capturing missing history and after 28th February 2017 all the transfers will be done online. It was requested by all the DIOs to provide training on new features of eHRMS. It was decided that Sh. Sanjay Kumar will hold demonstration cum training for all DIOs before the next meeting through VC. Sh. Sanjay Kumar informed that Help documents are already under preparation for new features and agreed that demo-cum-training will be held for all the DIOs.

Sh. Vimal Sharma, PSA, explained about physical verification activity to be carried out by all the districts. He asked all the DIOs to send feedback about HCL AMC bills. He asked all the DIOs to send status of PM and carry out the annual physical verification of stock items.

Thereafter, **the DIOs informed about the actions taken** on the points discussed during the last monthly review meeting and the **activities undertaken** by them during the month.

Reporting/issues common to all DIOs:

- **eKalyan:** It was again requested that all the DIOs should send feedback/ comments for Web based eKalyan Software.
- **NDAL & ALIS:** Most of the DIOs informed that the software is being tested and problems are being communicated to DIO Shimla, who will get these resolved through the National team.
- **eHimbhoomi:** It was informed that only few DIOs have provided feedback related to web based software. It was agreed by all that for at least new tehsils instead of old client server based software, new web based software should be implemented. The DIO Hamirpur is testing the software extensively and providing requisite feedback.
- **Saarthi 4.0:** SW has been implemented successfully and problems are being reported to Sh. Bhupinder Pathak, DIO Kangra who is getting these resolved.
- **Vahan 4.0:** Testing is in progress. Sh. Pathak also added that for new locations there is no issue but for old sites there are some issues which are being resolved. The storage of these documents in Digital Locker of the individual was discussed and Sh.Pathak informed about the information available on the website.
- **Hot Dak Tracking System:** It was informed that request has been received for implementation from Department of Ayurveda and Women and Child Development department. Sh. Pankaj Gupta, DIO Shimla is coordinating for implementation.
- **Service Plus:** It was informed that service for issuance of NOC by Department of Fire Services is being tested by the department. Sh. Anurag Gupta, ADIO, Una is developing service for issuance of Disability Certificates. It was decided that for request of service received from Ayurveda Department, Sh. Anurag will develop the same.

The SIO enquired about the status of updations of Addresses of District as per requirement of NIC HQ. It was informed that all the DIOs have updated the same.

The SIO also enquired about the joining status of Treasury Manpower at the districts and all the DIOs were requested to expedite the matter.

The SIO discussed about the technology regarding pushing of data to digital locker and eSign so that same can be used in NIC applications. It was informed that DIT has used this technology in eDistrict Application. It was decided that mail should be sent to DIT eDistrict team for sharing the Technology.

It was also decided that Mobile App for transport will be demonstrated by 28th February and also Sh. Pathak will submit the article for Informatics, current issue.

The Meeting ended with vote of thanks.
